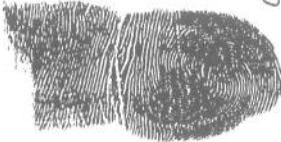

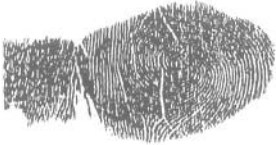

 - xii) The Vendor herein has full right, power and authority to sale and transfer the said property;
