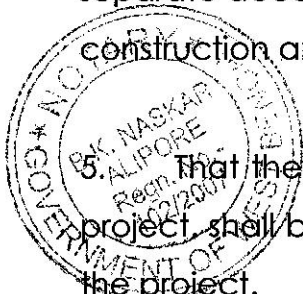
2. That the said land is free from all encumbrances.

3. That the time period within which the project shall be completed by me/promoter is 20.11.2024.

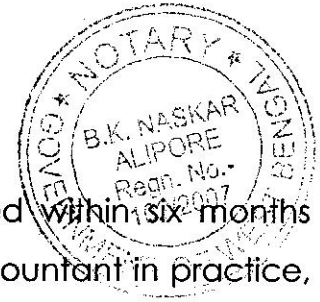

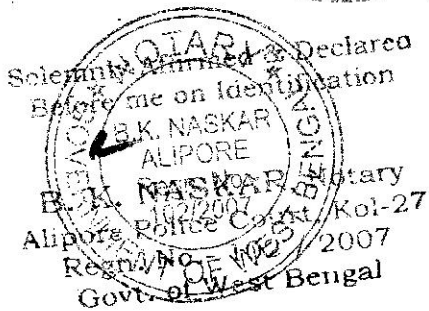
8. That the promoter shall take all the pending approvals on time, from the competent authorities.

10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.

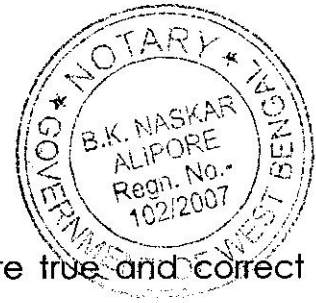
