**Terms and conditions**

1. That the provision of the WB. That the licence shall not store any place so because any article like petroleum product, any inflammable oil or spirit, any article of combustile nature etc. In excess of the quantity prescribed under Indian Petroleum Act, 1989 and shall take all precautionary measures to safegaurd against any incidence of fire.
