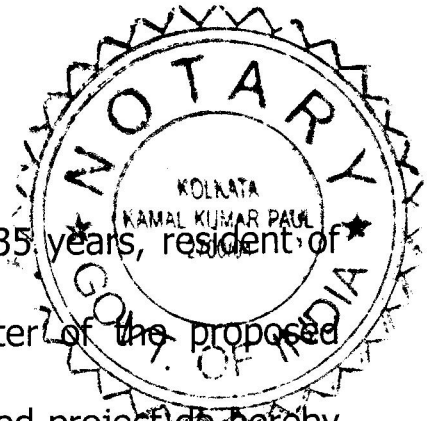

3. That the time period within which the period shall be completed by me/promoter is 31st March, 2022.

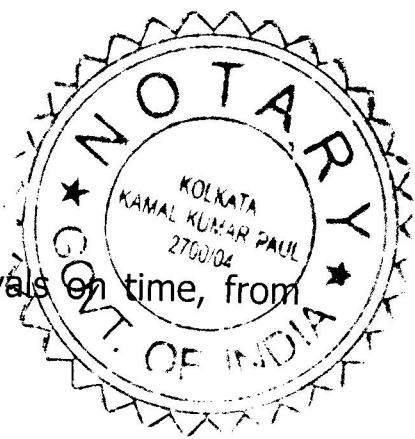
