SUKLA BASU, daughter of Late Sudhir Krishna Basu, by faith Hindu, by occupation Retired, by nationality Indian, residing at 32/8/3, Motilal Mullick Lane, Police Station Baranagar, Kolkata - 700 035, hereinafter called and referred to as the "DONOR" (which term or expression shall unless excluded by or repugnant to the context or subject be deemed to mean and include her heirs, executors, legal representatives, administrators and assigns) of the ONE PART.

SRI BISWANATH BASU, son of Late Sudhir Krishna Basu, by faith Hindu, by occupation Retired, by nationality Indian, residing at 32/8/3, Motilal Mullick Lane, Police Station Baranagar, Kolkata - 700 035, hereinafter called and referred to as the "DONEE" (which term or expression shall unless excluded by or repugnant to the context or subject be deemed to mean and include his heirs, executors, legal representatives, administrators and assigns) of the OTHER PART.

WHEREAS by virtue of a Bengali Kobala dated 18/10/1974, registered before the Sub Registrar at Cossipore Dum Dum and entered in Book No.I, Volume No.140, Pages 131 to 136, Being No.8383 for the year 1974, Smt. Sukla Basu, the Donor herein purchased ALL THAT piece and parcel of homestead land measuring 2 (two) Kattahs 2 (two) Chittaks 29 (twenty nine) sq. ft. more or less lying and situate in Mouza Bonhooghly, Khatian Nos.201 & 567, Dag Nos.2020 & 2025, J. L. No.6, R. S. No.5, Touzi No.3027, being portion of Premises No.32/8, Motilal Mullick Lane, Police Station Baranagar, Kolkata - 700 035 from the erstwhile owner Smt. Amiya Mondal for valuable consideration mentioned therein.

AND WHEREAS after the said purchase said Smt. L. No.6, R. S. No.5, Touzi No.3027, being Premises No.32/8/3, Motilal Mullick Lane, Police Station Baranagar, Kolkata - 700 No.32/8/3, Motilal Mullick Lane, Police Station Baranagar, Kolkata - 700 No.12, within the local limits of Baranagar Municipality, demarcated and

as the Said Property with intend to vest the same in, grant, convey, transfer, give, gift and assure unto and to the use of the Donee, freely and voluntarily and TO HAVE AND TO HOLD the same for his sole use and benefit absolutely and unconditionally for ever.

THE DONOR HEREBY DECLARES AS FOLLOWS:

- 1. THAT the Donor had / has never made or done anything or executed any Deed or committed or knowingly suffered to the contrary to the title of the Donor and the Donor is lawfully seized and possessed of or otherwise well and sufficiently entitled to the Said Property and the different portions thereof hereby granted free from all encumbrances and charges whatsoever and that the Donor has full power and indefeasible right and authority to grant, settle, transfer, gift and assure the Said Property hereby granted unto the Donee in the manner aforesaid and according to the true intent and meaning of these presents.
 - 2. That it shall be lawful for the Donee at all times hereafter peacefully and quietly to enter into and upon and hold and occupy and enjoy the Said Property hereby granted without any hindrance, interruption, disturbance, claim or demand whatsoever by the Donor or any person or persons claiming any estate, right, title or interest from under through or in trust for the Donor and freely and clearly and absolutely acquitted, exonerated and forever discharged or otherwise by the Donor well and sufficiently saved defended kept harmless and indemnified of and from and against all charges and encumbrances whatsoever made done executed or occasioned by the Donor.

- 3. That the Donor and all persons claiming any right, title or interest in the different portions of the Said Property hereby gifted through from under or in trust for the Donor shall and will from time to time and at all times hereafter do or execute or cause to be done or executed all such lawful acts, deeds, things, whatsoever for further and more perfectly conveying and assuring the Said Property and every part thereof hereby granted unto the Donee as may be reasonably required according to the true intent and meaning of this Deed.
- 4. 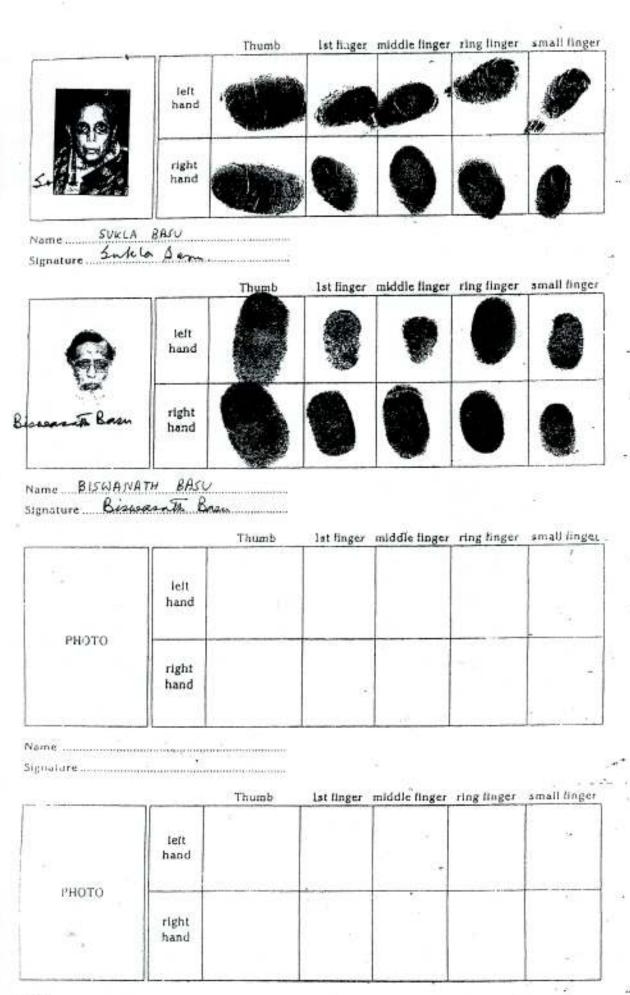

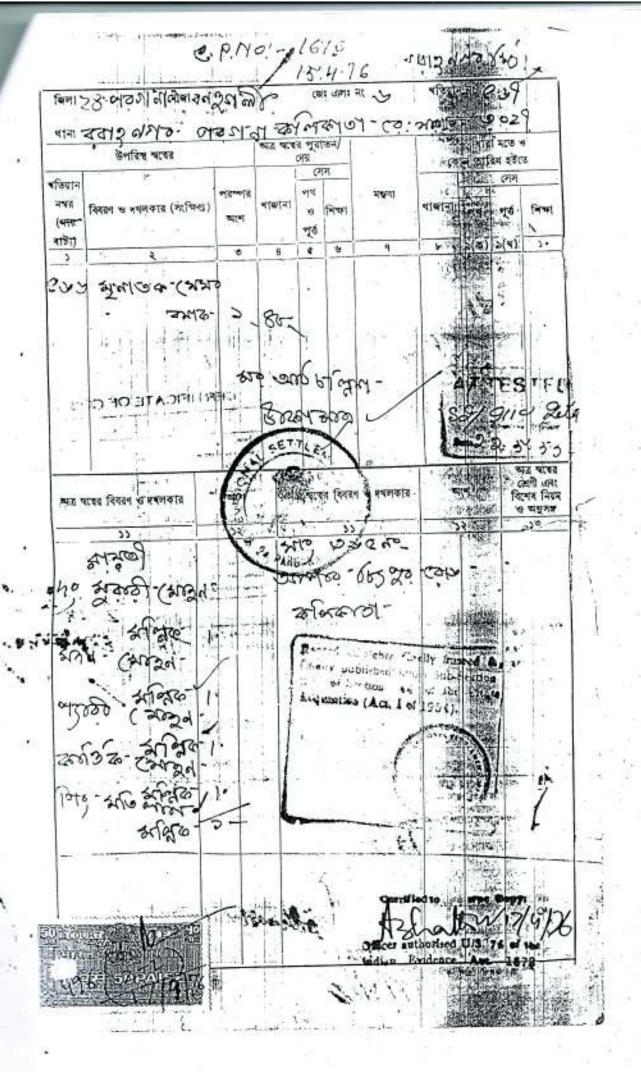

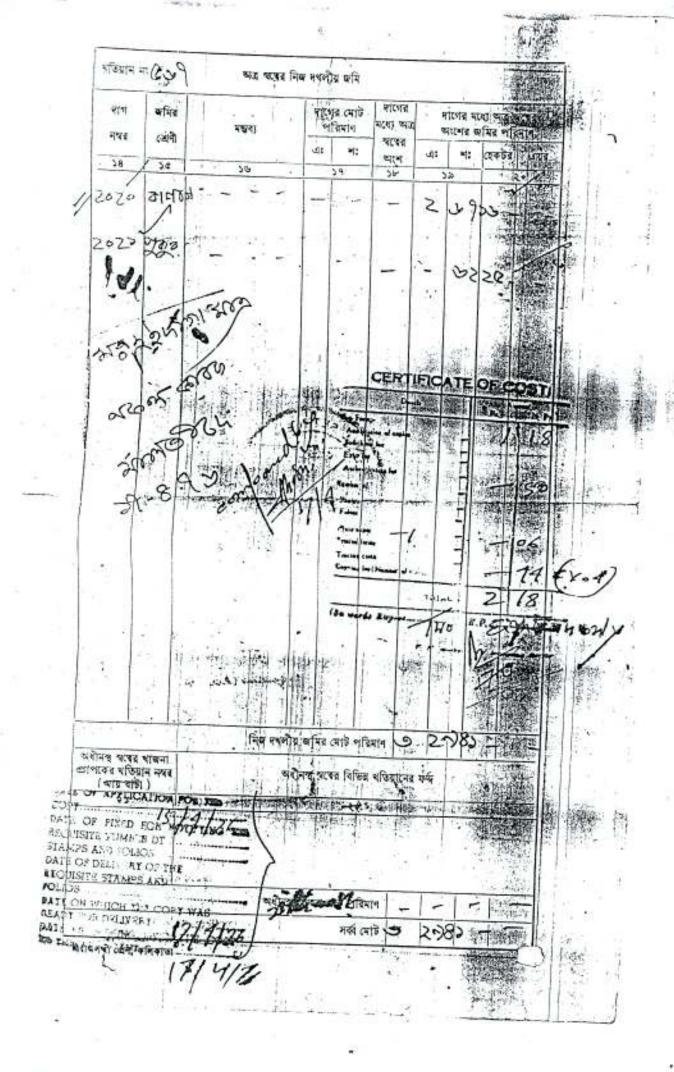
