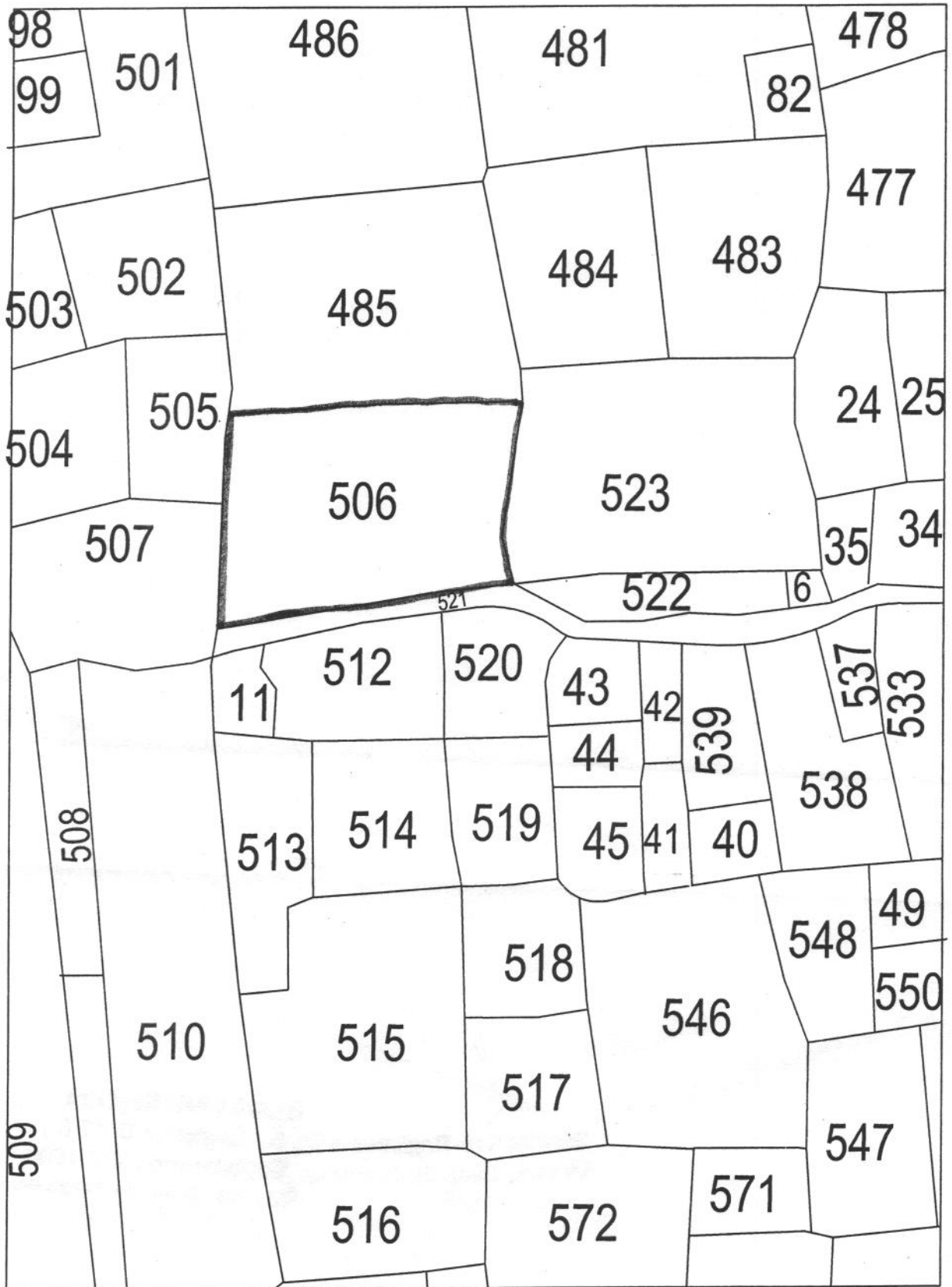

SHOWN IN RED BORDER





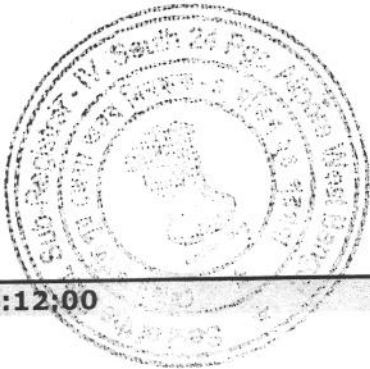
