1. 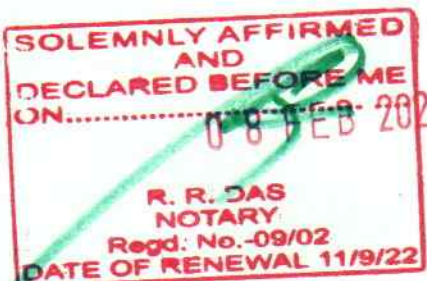
