1.INTRODUCTION

1.1 Plot

ALL THAT land measuring 1 Bigha 5 cottahs and 4 Chittacks together with old brick built dwelling house standing thereon being Municipal Premises No. 12, Ballygunge Park Road, Kolkata - 700 019, P.S. Ballygunge (previously) at present Karaya.

1.2 Scope of Assignment

The scope of the assignment is to conduct a due diligence and fact finding exercise covering scrutiny, examination, verification and checking of the Title Deeds & other relevant documents and reporting on the Title, ownership, marketability, encumbrances and government actions, if any, regarding aforesaid Plot of land at Premises No. 12, Ballygunge Park Road, Kolkata - 700 019, P.S. Ballygunge.

1.3 Scope of Limitation

The Scope of our review is limited by the following general parameters:

- We have assumed that the documents perused by us in connection with the aforesaid land are the only documents relating to the Land.

2. APPROACH TO DUE DILIGENCE

We adopted the following approach to ensure best result of due diligence and fact finding exercise.

2.1. Scrutinizing the documents

Based on the above mentioned scope of work we have scrutinizing the documents as provided to us by the Client and the discussions with the Client's representatives as described in **Annexure-A** hereto, and on comprehensive perusal thereof, the legal veracity of their contents were examined and analyzed, and this Title Verification report is limited and restricted to the review of various documents provided and made available by the Client and the searches undertaken at the various offices of the authorities, Government departments, MCA website etc. as mentioned here in below.

3. SEARCHES

3.1 Verification of registration of registered documents and search about registered encumbrances

To verify the legal authenticity of the Deed of Conveyance - a fact finding team from our office visited the following offices on 21st March 2017 for inspection of the records.

Our approach to inspection was to find the relevant registers (book) in which entries of the registered documents are made and the concerned documents executed in respect of immovable properties are posted. We have conducted searches and inspected documents only for last 15 years i.e. from the year 2002 to 2017 at the office of –

3.2 Searches at Courts

Our litigation team visited the office of the 2nd Judge, Senior Division at Alipore and 2nd Civil Judge, Junior Division, which are the appropriate Court of Territorial Jurisdiction to ascertain whether any Title Suit, or Money Suit is pending against the Client. Upon inspection it was found that no Title Suit or Money Suit has been filed against the Client during the period 2016 - 2017.

Our litigation team visited the Sheriff's Office at High Court, Kolkata on 10th April, 2017, to ascertain whether any decree is pending for execution Title Suit, against the Client. Upon inspection it was found that no decree is pending for execution against the client.

Searches at the Office of Registrar of Companies through the MCA 3.3. website

Our team led by Mr. Ankur Singhi, made elaborate searches through MCA (Ministry of Corporate Affairs) website to find out if any charge has been created against the aforesaid land.

It was observed that one charge by way of Mortgage has been created against the aforesaid land vide Deed No. 02441 for the year 2014 in favor of Axis Finance Limited, the same has been duly closed. At present there is no subsisting charge against the aforesaid property.

5. OBSERVATIONS

On the basis of the documents perused by us and the searches made by our team and representatives, the important facts pertaining to the Title of the said land and our observations are as follows:

Tarini Churn Law son of Late Chandi Churn Law was the owner of all that land admeasuring approximately 1 Bigha 5 Cottahs and 4 Chittaks together with old brickbuilt dwelling house situated at municipal Premises No. 12, Ballygunge Park Road, Kolkata - 700 019, Police Station previously Ballygunge at present Karaya within Municipal Ward No. 65 of the Kolkata GAI Municipal Corporation.







- The said Tarini Churn Law (since deceased), during his lifetime by a 5.2 registered deed of trust dated 16th January 1945, registered in the office of the registrar of Calcutta and recorded in Book No. 1, Volume No. 35, Pages 129 to 136, being Deed No. 762 of 1945 (hereinafter referred to as the Trust Deed) amongst others, transferred the aforesaid Premises to be held in trust and the said Trust Deed inter alia provides that the Settler and the Trustee shall hold the trust properties which included the said premises in trust for the benefit of the settler's son Sri Jadab Churn Law and his heirs and that upon the father's death of the settler and the trustee, the Trust Property shall devolve absolutely and forever upon the said Jadab Churn Law and his heirs, executors, administrators and legal representatives.
- The said Tarini Churn Law died intestate and upon his death the said trust 5.3 had come to an end and all the trust properties including the said premises stood vested in his son Jadab Churn Law absolutely and forever.
- 5.4 During the lifetime of Said Jadab Churn Law, his wife Smt. Ruby Law and his two daughters namely Devalina Law and Sharmistha Law filed a suit in the second court of Munsif at Alipore being Title suit No. 381 of 1983 for the following reliefs:
 - a) For a decree declaring that the plaintiffs each have got equal share and right, title interest in the suit properties with that of the defendant
 - b) For a decree declaring that Defendant has got no right to sell and to encumber, mortgage, transfer, lease out or alienate the suit properties without written consent and permission of the plaintiffs
 - c) For a decree for permanent injunction restraining the defendant to transfer or encumbering the suit properties to any person or persons without the written consent of the plaintiffs
 - d) For a decree for permanent injunction restraining the defendant from disturbing possession of the plaintiffs in the suit properties and also

restraining the Defendant from realizing rent or inducting any tenant in the suit properties without the written consent of the plaintiffs.

- e) For issue of temporary injunction
- f) For appointment of Receiver
- g) For costs of the suit
- h) Any other relief /reliefs as the Plaintiffs are entitled to law and equity
- Disputes in the said suit were referred to the sole arbitration of Mr. 5.5 Dwaipayan Mitra (thereinafter referred to as the Arbitrator) who made and published his award dated 5th November 1984 (thereinafter referred to as the said Award) whereby the said Arbitrator had awarded that Jadab Churn Law, Ruby Law, Devalina Law and Sharmistha Law were entitled to undivided 1/4th share or interest therein.
- In pursuance of an application having been filed in the said suit, the said suit 5.6 was decreed on 27th March 1985 in terms of the said award.
- In the premises and by virtue of the said award and the said decree passed in 5.7 the said suit, the said Jadab Churn Law, Smt Ruby Law, Devalina Law and Sharmistha Law became entitled to the said properties including premises No. 12 Balllygunge Park Road , Kolkata each one of them being entitled to undivided 1/4th share or interests therein.
- On the application of Jadab Churn Law, Smt Ruby law, Devalina Law and 5.8 Sharmistha Law have been mutated as the joint owners of the premises in the records of the Calcutta Municipal Corporation

After mutation of the premises, the Jadab Churn Law, Smt Ruby law, Devalina 5.9

Law and Sharmistha Law obtained the ULC Clearance certificate from the

- 5.10 Jadab Churn Law died intestate on or about 4th August 2005 leaving behind him surviving his wife Ruby Law and his two daughters namely Devalina Law and Sharmistha Law who upon his death became entitled to the said Premises each one of them being entitled to undivided 1/3rd (one third) share or interest therein.
- 5.11 In the circumstances Ruby Law and her two daughters namely Devalina Law and Sharmistha Law became entitled to undivided 1/3rd (one third) share or interest in or upon the said premises.
- 5.12 Thereafter the said Ruby Law and her two daughters namely Devalina Law and Sharmistha Law agreed to sell the said premises and M/s Forum Projects Pvt Ltd.
- 5.13 By a Registered Deed of Sale dated 13th December, 2011 registered at the office of District Sub Registrar-III, South 24 Parganas and recorded in Book No-I, Volume No-19, Pages from 10259 to 10277 being No. 09700 for the year 2011 the said Smt Ruby Law, Devalina Law and Sharmistha Law sold all that 1 Bigha 5 cottahs and 4 Chittacks together with old brick built dwelling house standing thereon being Municipal Premises No. 12, Ballygunge Park Road, Kolkata-700 019, P.S. Ballygunge now Karaya to M/s Forum Projects Pvt Ltd.
- 5.14 By virtue of such deed Forum Projects Pvt. Ltd. became the owner of all that land measuring 1 Bigha 5 cottahs and 4 Chittacks together with old brick built dwelling house standing thereon being Municipal Premises No. 12, Ballygunge Park Road, Kolkata-700 019 , P.S. Ballygunge now Karaya.

The said Forum Projects Pvt Ltd thereafter got their name mutated in the records of Kolkata Municipal Corporation with respect to the said premises.

As per the mutation certificate being No. 0053743 the property has been mutated in the name of the FORUM being Assessee No. 110650200123 on 02/02/2012.

6.3 Tax

Up to date municipal taxes has been paid as per the Tax receipts issued by Kolkata Municipal Corporation dated 26.05.2016

Building Plan

Building Plan being Building Plan Permit No. 2013070219 dated 27.02.2014 has been sanctioned by the Kolkata Municipal Corporation valid till 26.02.2019.









6.5 Title

The Land in question is a freehold land. M/S. FORUM PROJECTS PVT. LTD., has purchased the land by way of Deed of Conveyance dated December 13, 2011 with absolute right, title and interest.

6.6 Encumbrance(s):

We most diligently inspected index registers of 13 years maintained in the office of Additional District Sub-Registrar Office at Additional Registrar of Assurances I at Kolkata, District Sub Registrar III at South 24 Parganas, Additional District Sub Registrar Sealdah, we did not find any entry/document suggesting any registered encumbrance upon the Land in question except Deed No. 02441 for the year 2014 in favour of Bank/Financial Institution, however the mortgage has been satisfied.

6.5 Nature/ Status of land:

On the basis of our search it is found that the FORUM has legal and marketable title of the land
