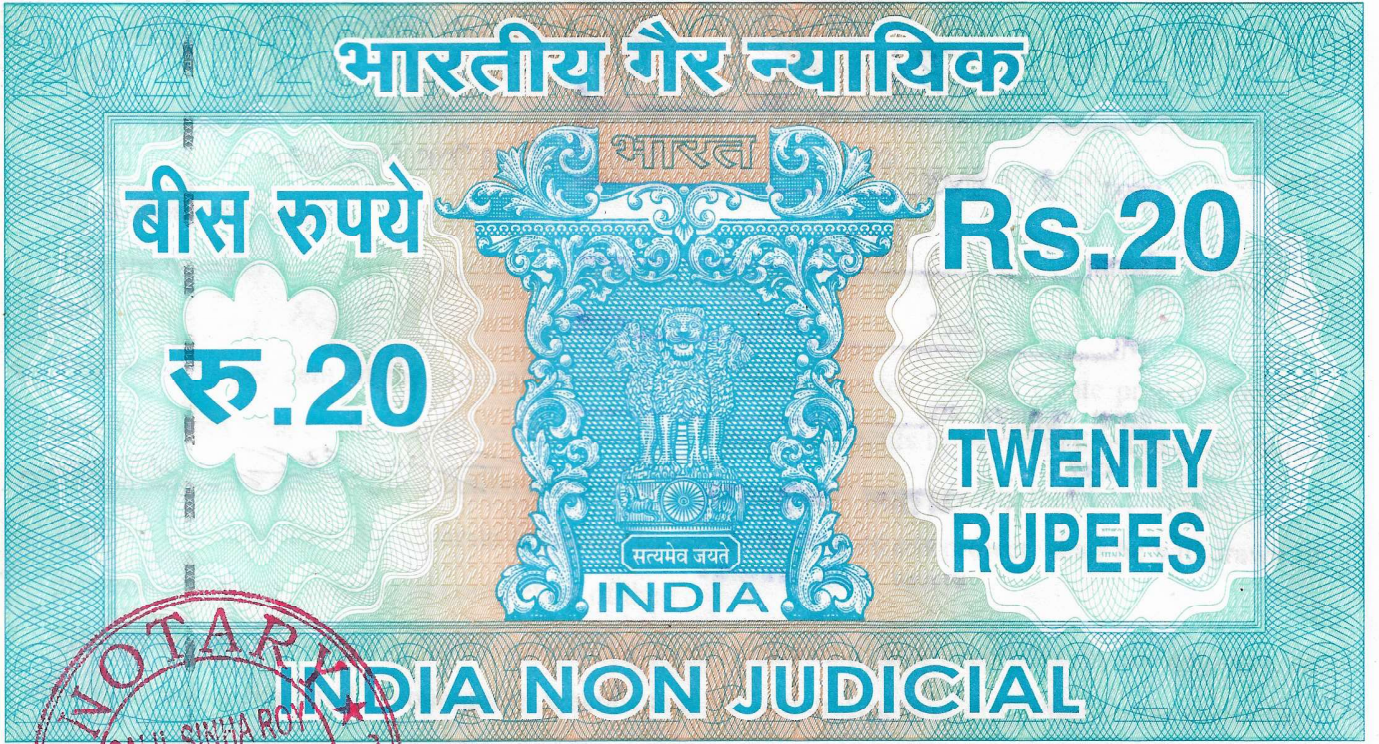

We, Swapan Kumar Banerjee (Son of Late Nanda Kumar Banerjee) and Dipayan Banerjee (Son of Swapan Kumar Banerjee) Partner of Ms. **SKB REALTECH** , promoter of the proposed project / duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:

1. That I Swapan Kumar Banerjee (Son of Late Nanda Kumar Banerjee) have / has a legal title to the land on which the development of the project is proposed

OR

Swapan Kumar Banerjee (Son of Late Nanda Kumar Banerjee) have / has a legal title to the land on which the development of the proposed project is to be carried out

AND

2. That the said land is free from all encumbrances.

OR

That details of encumbrances on the land on which development is proposed, is free from all encumbrances including details of any rights, title, interest or name of any party in or over such land, along with details.

3. That the time period within which the project shall be completed by me/promoter is 3/1
March, 2023

4. That Seventy per cent of the amounts realized by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate accounts to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

5. That the amounts from the separate accounts, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.

7. That the amounts from the separate account shall be withdrawn after it is certified by the engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project that I /promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and withdrawal has been in compliance with the proportion to the percentage of completion of the project.

8. That I /promoter shall take all the pending approvals on time, from competent authorities.

9. That I /promoter have/has furnished such other document as have been prescribed by the rule and regulations made under the Act.

10. That I/promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
