This Indenture

made this twenty-third day of April, One thousand nine hundred and thirty-one

Between The Trustees For the Improvement of Calcutta a body corporate constituted by the Calcutta Improvement Act of 1911 (Bengal Act V of 1911) and hereinafter referred to as "the Board" of the one part and Harendra Nath Banerjee at present residing at Jhargram Thannah Jhargram in the District of Midnapur son of late Babu Madhusudan Banerjee by caste Brahmin by occupation Government Service-holder (Munsiff) hereinafter called the "Purchaser" which expression shall, unless excluded by or repugnant to the context, be deemed to include his heirs, executors, administrators, representatives and assigns of the other part.

Whereas the Board are now absolutely seized and possessed of or otherwise well and sufficiently entitled, free from encumbrances, to the lands hereditaments and premises in the Schedule hereto more particularly mentioned and described and intended to be hereby granted, conveyed, transferred and assured and have contracted with the Purchaser for the absolute sale thereof to him at or for the price of Rupees Fifteen thousand and Fifteen.

Now This Indenture Witnesseth that in pursuance of the said Agreement and in consideration of the said sum of Rupees Fifteen thousand and Fifteen paid to the Board by the Purchaser before the execution of these presents (the receipt whereof the Board hereby acknowledge) the Board hereby grant, convey and transfer unto the Purchaser all the lands, hereditaments

hereto together with all leadings or service pipes laid from the main sewer
and water mains under the street to the boundary of the premises hereby trans-
ferred and conveyed but subject to the rights and liabilities attached to the
user of such leadings or service pipes as now are or may hereafter be laid
down in the Coimbatore Municipal Act or in any rules or bye-laws made there-
under or in any other Act rules or bye-laws for the time being in force re-
specting hereto and all buildings, out-houses, compounds, trees, fences, or
privileges, easements, rights, lights, appurtenances and appurtenances
whenever to the said lands, hereditaments and premises or any part thereof
belonging or in any way appertaining held used or occupied therewith and
all the estate, right, title, and interest, property, claim and demand what-
soever of the Board into or upon the same and every part thereof To Have
and To Hold the same unto the Purchaser for ever.




