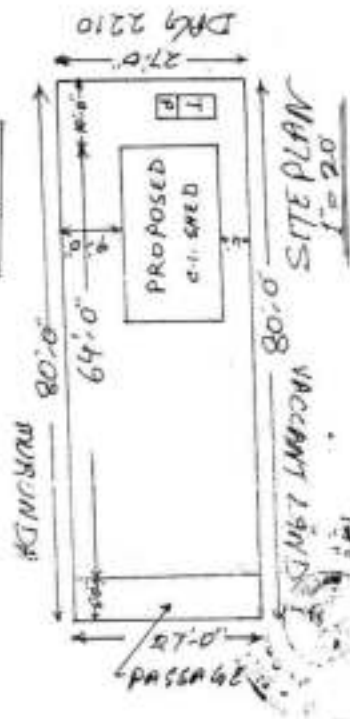
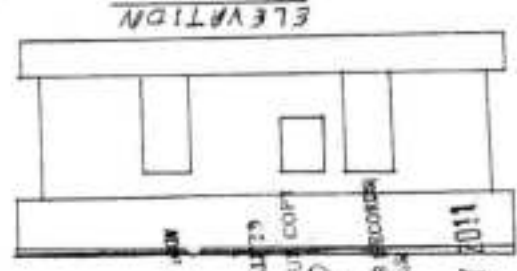
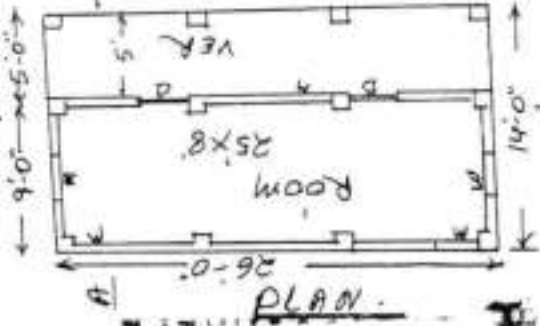
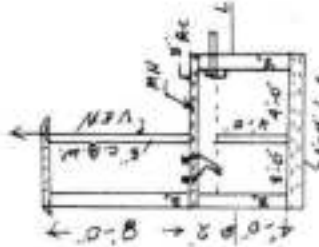
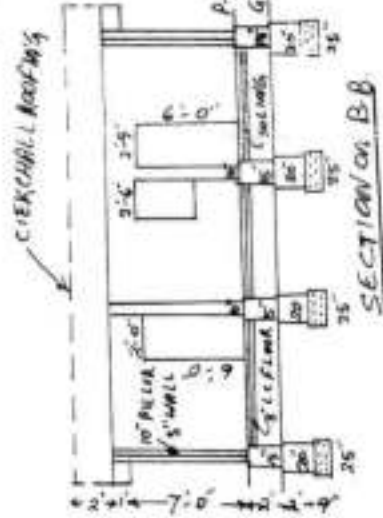
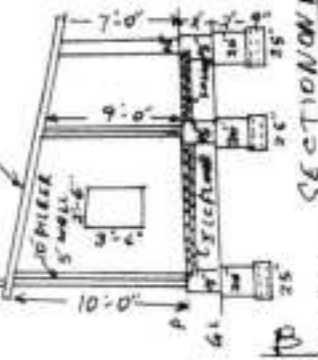
PLAN of PROPOSED CIEKCHALL SHED
