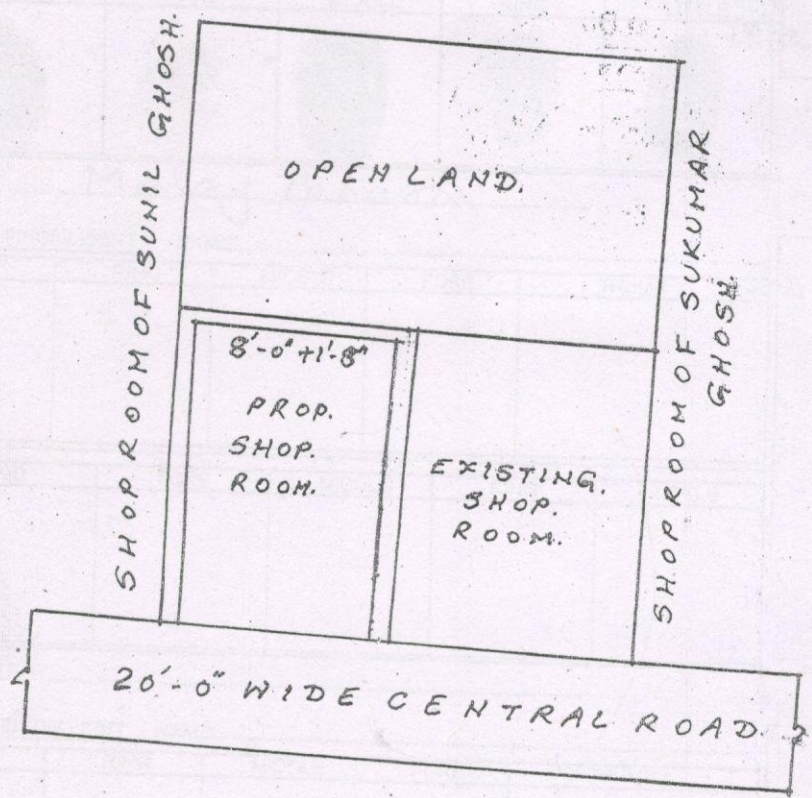
SITE PLAN OF R.S. DAG NO-9953, R.S. KHATI ANNO-2141,
