



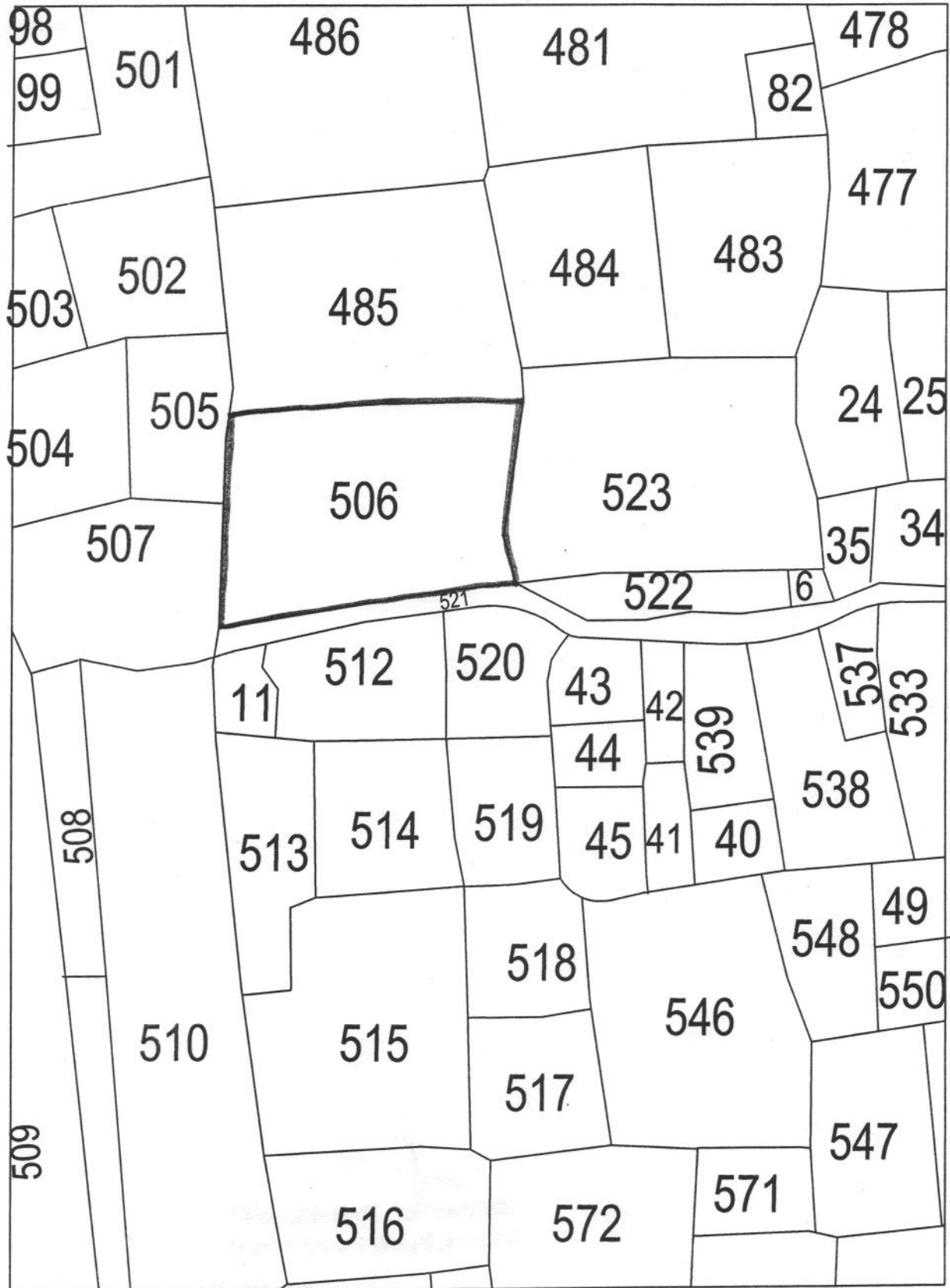

SHOWN IN RED BORDER

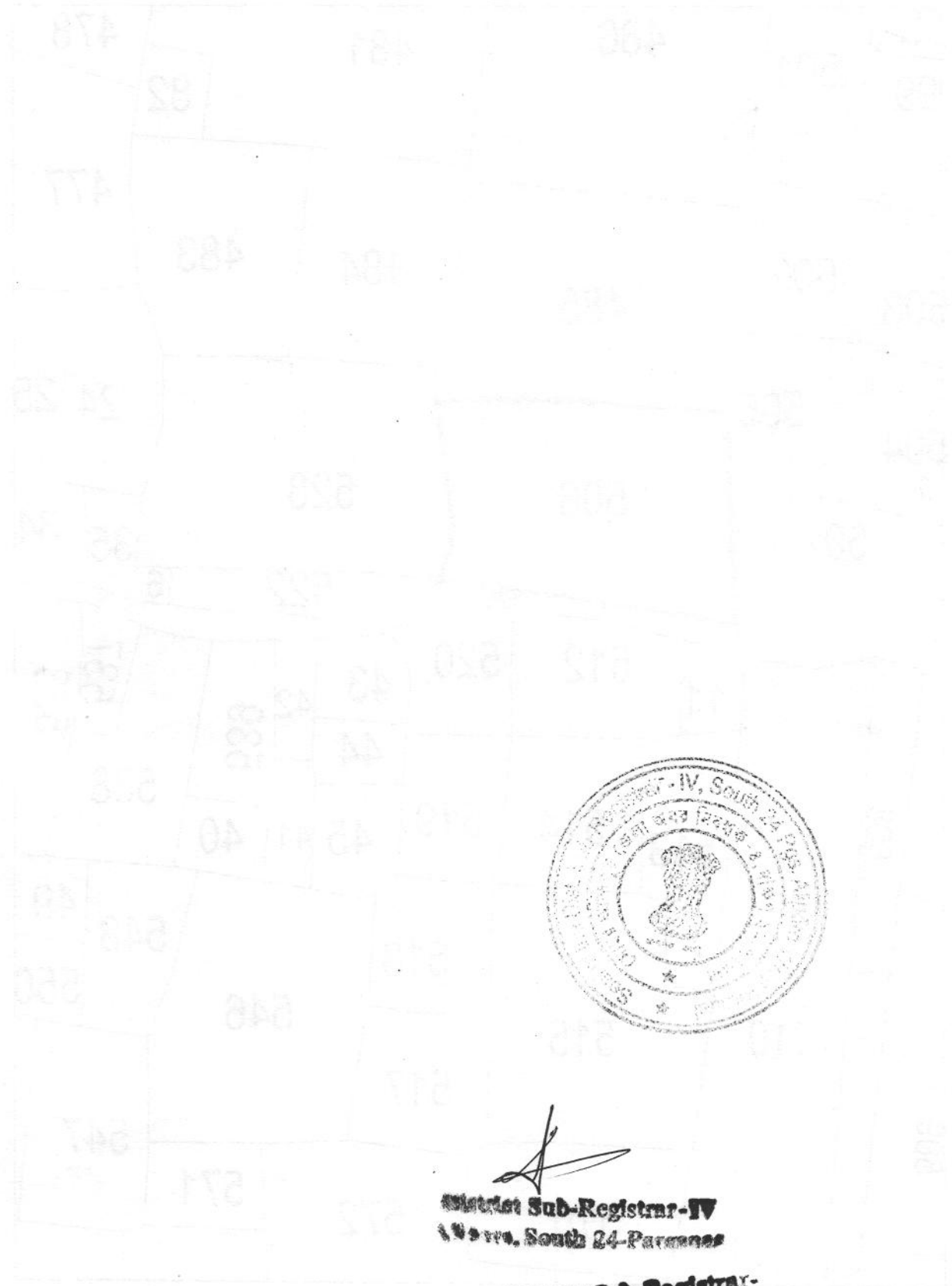
