

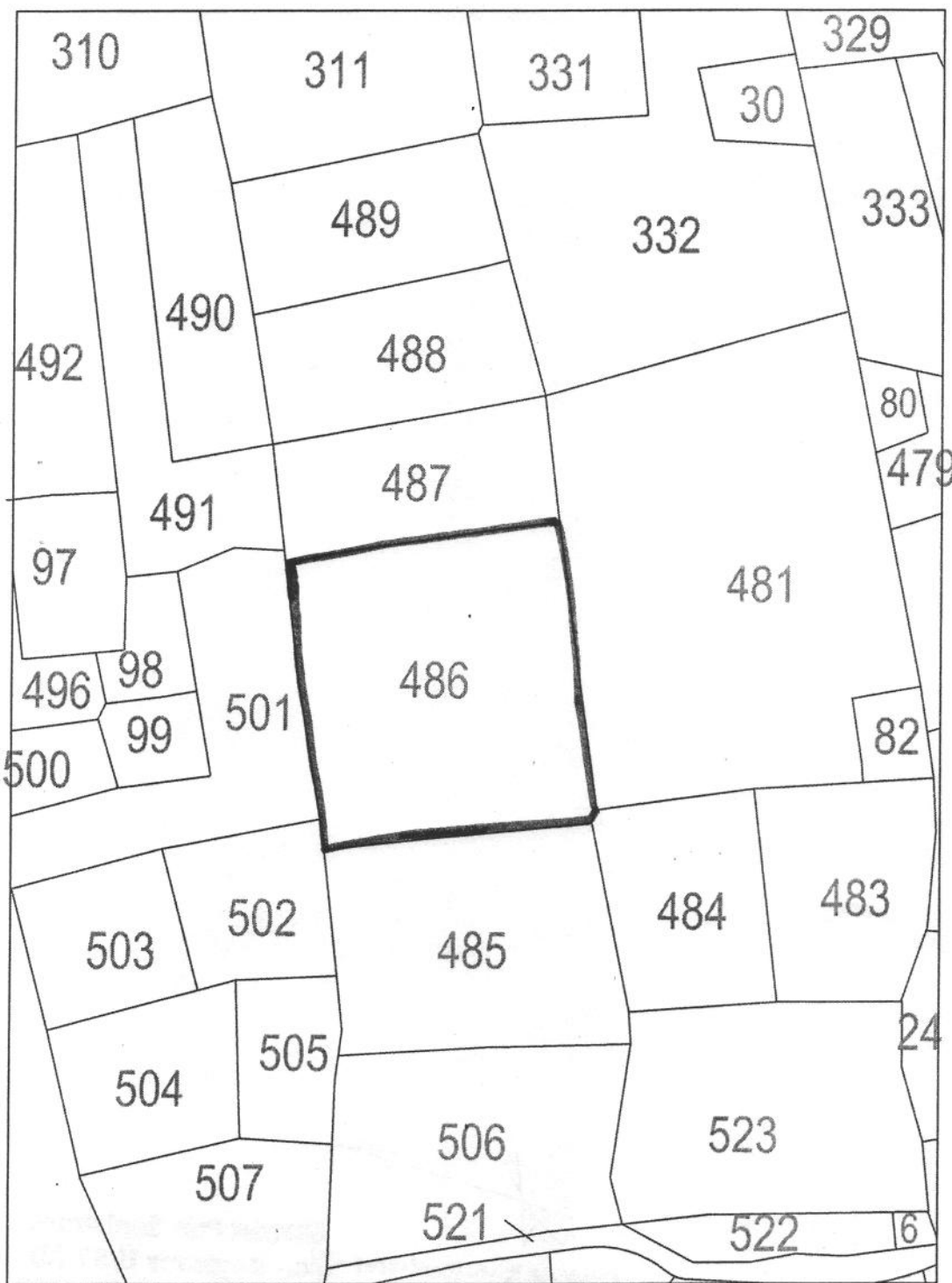

SHOWN IN RED BORDER

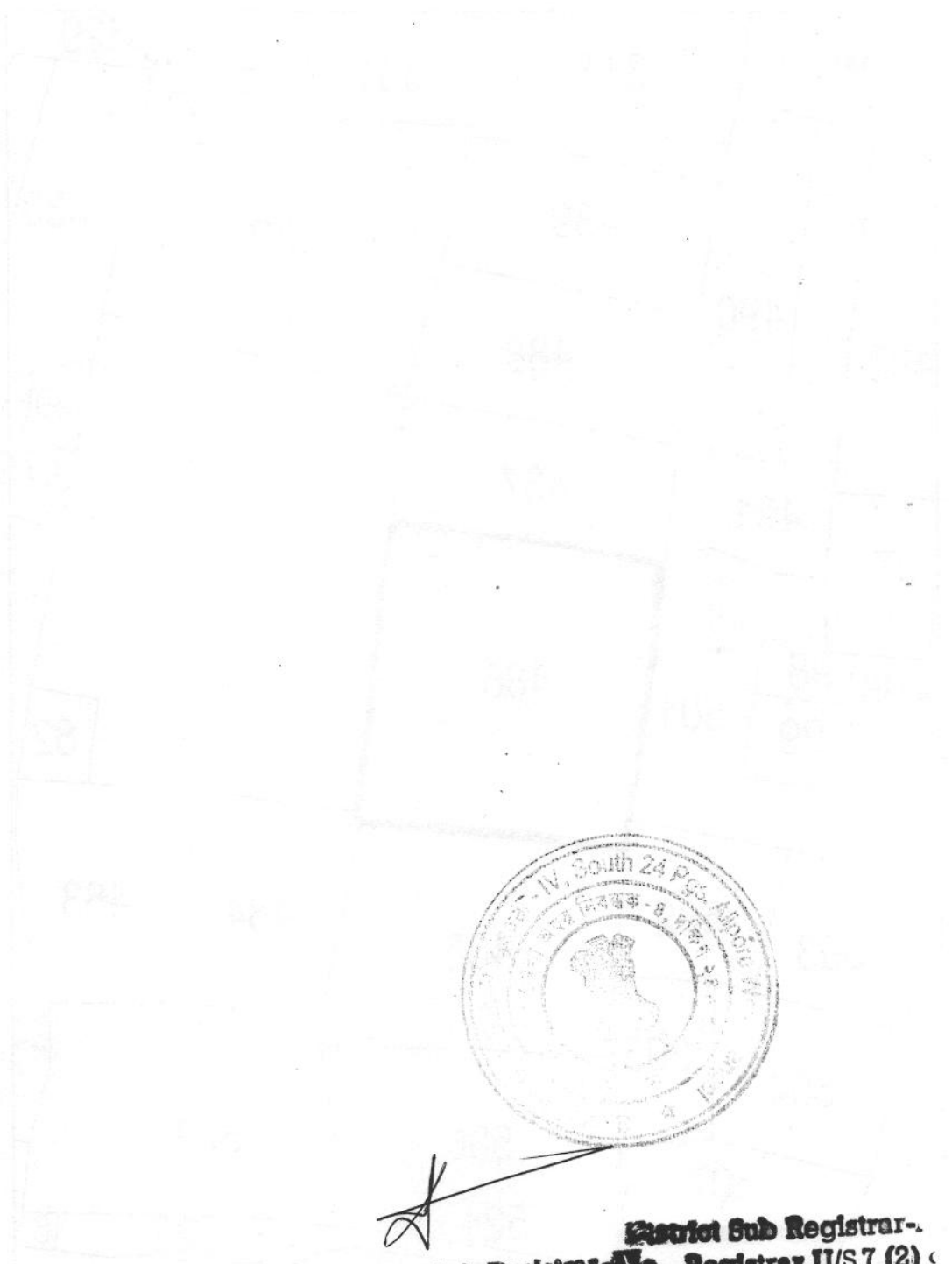
