- B. We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purpose of our audit.

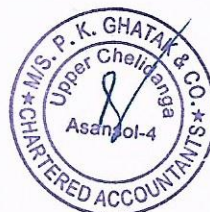
In our opinion, proper books of accounts as required by law, have been kept by the Company, so far as appears from our examination of those books and the aforesaid accounts are in agreement therewith.
