No rain water pipe should be fixed or discharged on Road or Footpath. Drainage plan should be submitted at the Rough Executive Engineer's Office and the sanction obtained before proceeding with the drainage work.

Before starting any Construction the site must conform with plans sanctioned and all the conditions as proposed in the plan should be fulfilled. The validity of the written permission to execute the work is subject to the above conditions.

A multiple pump has to be provided in supplying untreated water for the distribution in the building in case untreated water from street main is not available.

Plan for Water Supply arrangement including S.E.M.I.L.I.G. & O.H. reservoirs should be submitted at the Office of the Executive Engineer Water Supply and the sanction obtained before proceeding with the work of Water Supply any deviation may lead to disconnection/demolition.

CONSTRUCTION SITE SHALL BE MAINTAINED FREE FROM POLLUTION ACCORDING TO UNDERLYING SUBSTITUTES AS PER AMENDMENT DT. 31.03.2010 USE NO. 86/MAY/04 SECTION OF SCHEDULE IV OF THE BUILDING RULE 2018.

Non Commencement of Erection. For Erection within Five year will require fresh Application for Sanction.

All Building Materials to necessary & construction should conform to the standards specified in the National Building Code of India.
