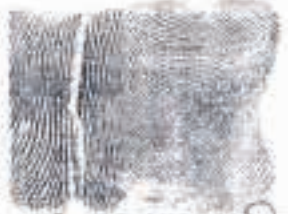

Rajarhat, District North 24 Parganas, Pin 700-135, and (12) ARIFA BIBI, wife of Ayub Ali Mistri, residing at 43, Sarat Basu Lane, (Angshik), Dum-Dum North, District North 24 Parganas, Pin 700 081, hereinafter jointly and/or collectively referred to as the "VENDORS" [which expression shall unless excluded by or repugnant to the subject or context be deemed to mean and include each of their respective heirs, successors-in-interest, trustees, executors, administrators, legal representatives and/or assigns] of the ONE PART AND (1) EXCEL SALES PRIVATE LIMITED, a Company incorporated under the Companies Act, 1956 having its registered office at VIP Enclave, Block- A, Flat No.104, VIP Road, Raghunathpur, Kolkata 700 059, and (2) HARAPPA NIRMAN PRIVATE LIMITED, a Company incorporated under the Companies Act, 1956 having its registered office at DC 9/28, Shastri Bagan, Deahbandhu Nagar, Kolkata 700 059, hereinafter jointly and/or collectively referred to as the "PURCHASERS" [which expression shall unless excluded by or repugnant to the subject or context be deemed to mean and include their respective successors-in-office, trustees, executors, administrators, legal representatives and/or assigns] of the OTHER PART:

WHEREAS

- A. By virtue of Records of Rights one HABUL MOLLA son of Late Haran Molla, was well seized and possessed of and/or otherwise well and sufficiently

entitled to **ALL THAT** piece or parcel of land measuring an area of total 47 (Forty Seven) Decimal, more or less, lying and situated at Mouza RAIGACHI, J.L. No.12, R.S. No. 194, Touzi No.169, comprised in C.S. Dag No.925, corresponding to R.S. Dag No.928, recorded under Jamidar Khatian 107, C.S. Khatian No.108, corresponding R.S. Khatian No.135, under P.S. Rajarhat, District 24-Parganas;

- B. By a Heba Bil Awuaznama, in bengali vernacular, dated the 3rd day of May, 1949, Said **HABUL MOLLA**, therein called "Daata" (Doner), gifted and transferred entirety of the aforesaid land, i.e. **ALL THAT** piece or parcel of land measuring an area of total 47 (Forty Seven) Decimal, more or less, lying and situated at Mouza RAIGACHI, J.L. No.12, comprised in C.S. Dag No.925, corresponding to R.S. Dag No.928, recorded under R.S. Khatian No.135, under P.S. Rajarhat, District 24-Parganas, unto and in favour of his four sons (1) **Abdul Latif Molla**, (2) **Abdul Malek Molla**, (3) **Mohar Ali Molla**, (4) **Kachimuddin Molla**, and his two grandsons, (5) **Albahar Molla**, and (6) **Mujibar Molla**, both son of Late Helaluddin Molla, therein collectively called as "Grahita" (Donee), and duly registered with the Sub Registry Office, Cossipur, Dum-Dum, recorded in Book No. 1, being No.1809 for the year 1949, absolutely and forever;
- C. The said **Mujibar Molla** died intestate leaving behind his wife (1) **Joynur Begam @ Biwi**, his son (2) **Motihar Molla** and his daughter (3) **Rifia Khatun** as his only legal heirs, who inherited all his share of land out of 47 (Forty Seven) Decimal, comprised in C.S. Dag No.925, corresponding to R.S. Dag No.928 lying and situated at Mouza RAIGACHI, J.L. No.12, , recorded under C.S. Khatian No.108, under P.S. Rajarhat, District 24-Parganas.
- D. By a Bengali Indenture of Conveyance dated the 21st day of September, 1988, registered at the office of the Sub -Registration Office Cossipore Dum Dum, Recorded in Book No. 1, Pages from 199 to 206 Being No. 8060 for the year 1988, the said (1) **Albahar Molla** son of Late Helaluddin Molla (2) **Motihar Molla** son of Late **Mujibar Molla** (3) **Joynur Begam @ Bibi** wife of Late **Mujibar Molla**, (4) **Rifia Khatun** wife of Sk. Mohammad and daughter of Late **Mujibar Molla**, sold, transferred and conveyed **ALL THAT** piece and parcel of land measuring 6.2666 (Six point two triple six) decimal, more or less, out of their share of land comprised in C.S. Dag No. 925 (by error typed as C.S. Dag No.25), corresponding to R.S. Dag No.928, (Total Area in Dag- 47 Decimal), lying and situated at Mouza RAIGACHI, J.L. No.12, recorded under C.S. Khatian No.108, under P.S. Rajarhat, District 24-Parganas, unto and in favour of (1) **Abdul Latif Molla**, (2) **Abdul Malek Molla** both sons of Late **Habul Molla**, (3) **Ajjar Rahman** and (4) **Kader Ali** both sons of Late **Mohar Ali Molla** and (5) **Mst. Amena Khatun** wife of Late

Kachimaddin Molla therein called the "Purchasers" of the Second Part, absolutely and forever;

- E. After the aforesaid gift and sale, the then heirs of Rahul Molla, amicably settled and adjusted among themselves the entire piece and parcel of land measuring 47 (Forty Seven) Decimal, more or less, comprised in C.S. Dag No. 925, corresponding to R.S. Dag No.928, lying and situated at Mouza RAIGACHI, J.L. No.12, recorded under C.S. Khatian No.108, corresponding to R.S. Khatian No. 135, under P.S. Rajarhat, District North 24-Parganas, which reflects in Records of Rights vide K.B. Khatian No. 77. The Vendors herein accept and confirm all the aforesaid adjustment and settlement, made by their ancestors, in respect of the aforesaid property.
- F. Thus, by virtue of the aforesaid, the said Abdul Latif Molla became owner of ALL THAT piece and parcel of land measuring 9.4 (Nine point Four) Decimal, more or less, lying and situated at Mouza RAIGACHI, J.L. No.12, comprised in R.S. Dag No.928, recorded under K.B. Khatian No.77, corresponding to L.R. Khatian No.1240, under P.S. Rajarhat, District North 24-Parganas, hereinafter called "the SAID PROPERTY", free from all encumbrances, more fully described in the SCHEDULE hereunder written;
- G. On 29th April, 1996, the said Abdul Latif Molla died intestate leaving behind his wife (1) Saharbanu Bibi, his two son (2) Abdul Ahad Molla, (3) Karim Ali Molla, and three daughters (4) Kariman Bibi, (5) Shakila Bibi, and (6) Rahila Bibi, as his only legal heirs, who inherited all his properties, including the Said Property;
- H. On 8th September, 2012, the said Rahila Bibi also died intestate leaving behind her husband (1) Ainal Gazi, her five son (2) Amir Gazi, (3) Abed Ali Gazi, (4) Akbar Gazi, (5) Saffat Gazi, (6) Mosiar Gazi, and one daughter (7) Arifa Bibi, as her only legal heirs, who inherited all her properties, including her share in the Said Property.
- I. Thus, (1) Saharbanu Bibi, (2) Abdul Ahad Molla, (3) Karim Ali Molla, (4) Kariman Bibi, (5) Shakila Bibi, (6) Ainal Gazi, (7) Amir Gazi, (8) Abed Ali Gazi, (9) Akbar Gazi, (10) Saffat Gazi, (11) Mosiar Gazi, and (12) Arifa Bibi, the Vendors herein, acquired good title, full power and absolute authority in the Said Property, free from all encumbrances, absolutely and forever;

- J. The Vendors due to paucity of funds and inability to administer and maintain the Said Property, have offered to sell the entirety of the Said Property and the Purchasers herein agreed to purchase the same at and for a Total Consideration of Rs.99,52,265/- (Rupees Ninety Nine Lac Fifty Two Thousand Two Hundred And Sixty Five only), according to prevailing market price in the locality and the same has been found fair and reasonable, the Vendors have agreed to sell and transfer the Said Property to the Purchasers.

NOW THIS INDENTURE WITNESSETH as follows:

1. In pursuance of agreements and in consolidated consideration of the sum of Rs.99,52,265/- (Rupees Ninety Nine Lac Fifty Two Thousand Two Hundred And Sixty Five only), duly paid by the Purchasers to the Vendors only at or before the execution of this instruments (the receipt whereof the Vendors doth hereby as well as by the receipt and memo hereunder written admit and acknowledge and of and from the payment of the same or every part thereof forever acquit release and discharge the Purchasers as also every portion of the demised plot of land free from the same) the Vendors doth hereby grant sell convey transfer assign and assure unto the Purchasers **ALL THAT** piece and parcel of land measuring 9.4 (Nine point Four) Decimal, more or less, lying and situated at Mouza RAIGACHI, J.L. No.12, comprised in R.S, Dag No. 928, recorded under K.B. Khatian No.77, corresponding to L.R. Khatian No.1240, within the limit of Rajarhat Bishnupur No.1 Gram Panchayat, under P.S. Rajarhat, District North 24-Parganas, and which is hereinbefore as well as hereinafter referred to as "the **Said Property**", **OR HOWSOEVER OTHERWISE** the Said Property and every part thereof now are or is hereto before were or was situated butted and bounded called known numbered described distinguished **TOGETHER WITH** all rights, liberties, title, interest, easements, privileges, appurtenances and appendages whatsoever or the said property or any and every part thereof belonging to or in any way, appertaining to or usually held, used occupied or enjoyed therewith or reputed to belong or be appurtenant thereto **AND** the reversion or reversions remainder or remainders and all rents issues and profits thereof and all and every part thereof, hereby granted sold and conveyed transferred assigned and assured or expressed or intended so to be **AND** all the estate, rights, liberties, title, interest, inheritance, use, possession, property, claim, demand and other legal incidents thereof whatsoever, of the Vendors unto and upon the said property and every part thereof and all other evidence of title whatsoever in any way relating to or concerning the said property which now are or

hereafter shall or may be in possession, power of control of the Vendors or any other person or persons from the Vendors and procure the same without any action or suit either in law or in equity **TO HAVE AND TO HOLD** the Said Property, hereby granted transferred, sold, conveyed and assigned or expressed or intended so to be with the appurtenances unto the Purchasers absolutely and forever, free from all encumbrances, trust, liens, lispendends, charges, attachments, claimants, requisitions, acquisitions and alignment whatsoever.

2. **THE VENDORS DOTH HEREBY COVENANT WITH THE PURCHASERS:**

- i) **THAT** notwithstanding any act, deed, matter or thing whatsoever by the Vendors or their predecessor in title or any of them done executed or knowingly suffered to the contrary, the Vendors is fully and absolutely seized and possessed of or otherwise well and sufficiently entitled to the Said Property hereby granted and conveyed or expressed or intended so to be for a perfect indefeasible estate or inheritance without any manner or condition, use, trust or other thing whatsoever to alter or make void the same; and
- ii) **THAT** notwithstanding any such act, deed or thing whatsoever aforesaid, the Vendors now has good right, full lawful and absolute authority and indefeasible title to grant, convey, transfer and assign the Said Property hereby granted, conveyed, transferred and assigned or expressed or intended so to be with the appurtenances unto and to the use of the Purchasers in the manner aforesaid and according to the true intent and meaning of these presents; and
- iii) **THAT** the Purchasers shall and may from time to time and at all times hereafter peaceably and quietly hold occupy possess and enjoy the Said Property hereby granted, conveyed, transferred and assigned and received and take rents, issues and profits thereof for its absolute use and benefit without any lawful hindrance, interruption, disturbance or any person eviction or demand whatsoever from or by the vendors or any person or persons whatsoever; and
- iv) **THAT** free and clear, freely and clearly and absolutely acquitted exonerated and released or otherwise by and at the costs and expenses of the Vendors well and sufficiently saved defended kept harmless and other estate rights, title, claim, mortgage, charge, lien, lispendence and attachments whatsoever; and

- V) **THAT** further the Vendors and all person having or lawfully or equitably claiming any estate, right, title or interest whatsoever into or upon the Said Property or any and every part thereof from, under or in trust for the Vendors and/or their and each of their respective predecessor-in-title or any of them shall and will from time to time and all times hereafter at the requests and costs of the Purchasers do and execute or cause to be executed or done all such acts, assurances and things whatsoever for further better and more perfectly assuring the Said Property hereby granted, conveyed, transferred and assigned or expressed or intended so to be and every part thereof unto and to the use of the said Purchasers in the manner aforesaid as may be reasonably required; and

- VII) **THAT** no notice issued under the Public demands recovery Act, has been served on the Vendors nor any such notice has been published; and
- VIII) **THAT** the Vendors have not yet received any notice of requisition or acquisition of the property described in the Schedule below and the Said Property has not been affected by any scheme of road alignment or for any other purposes; and
- (X) **THAT** the Purchasers and all person claiming through or under the Purchasers have undisputed and all manner of rights through or over the Said Property and all other rights of easements at law and in equity; and

- XIII) **THAT** the Vendors shall and will make such affidavits and sign all papers and documents as may be necessary for the purpose of effecting mutation of Purchasers' name in the Record of Rights, as well as in the records of local authority;
- XIV) **THAT** simultaneously with the execution of this deed, the Vendors have handed over all documents of title relating to the Said Property, unto the Purchasers.
- XV) **THAT** the Vendors hereby relinquish all their right, title, interest and claim of whatsoever nature in the land comprised in any part or portion of the R.S. Dag No.928, situated in Mouza Raigachi, J.L. No.12, P.S. Rajarhat, District North 24 Parganas in favour of the Purchasers and further the Vendors hereby declare, affirm and assure that after execution of this deed the Vendors have no claim, right, title, interest of whatsoever nature in any part or portion of the land comprised in R.S. Dag No.928, Mouza Raigachi, J.L. No.12, P.S. Rajarhat, District North 24 Parganas.
