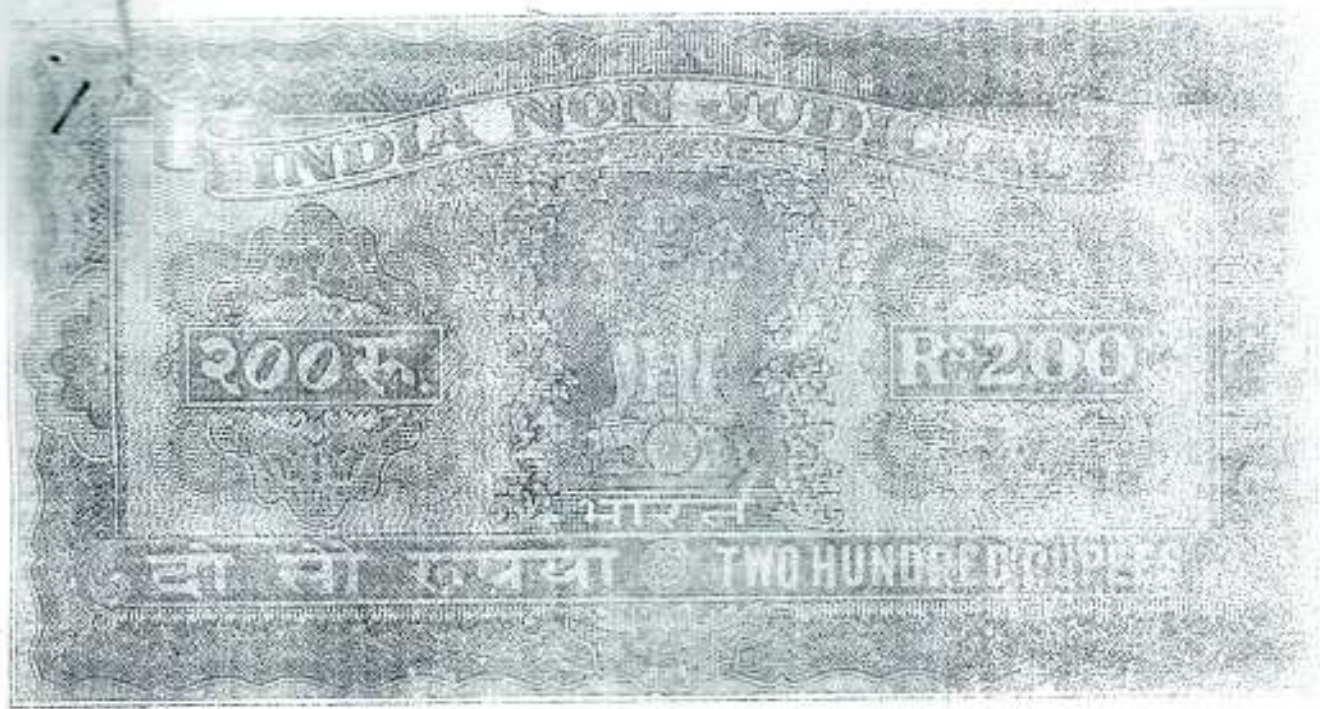

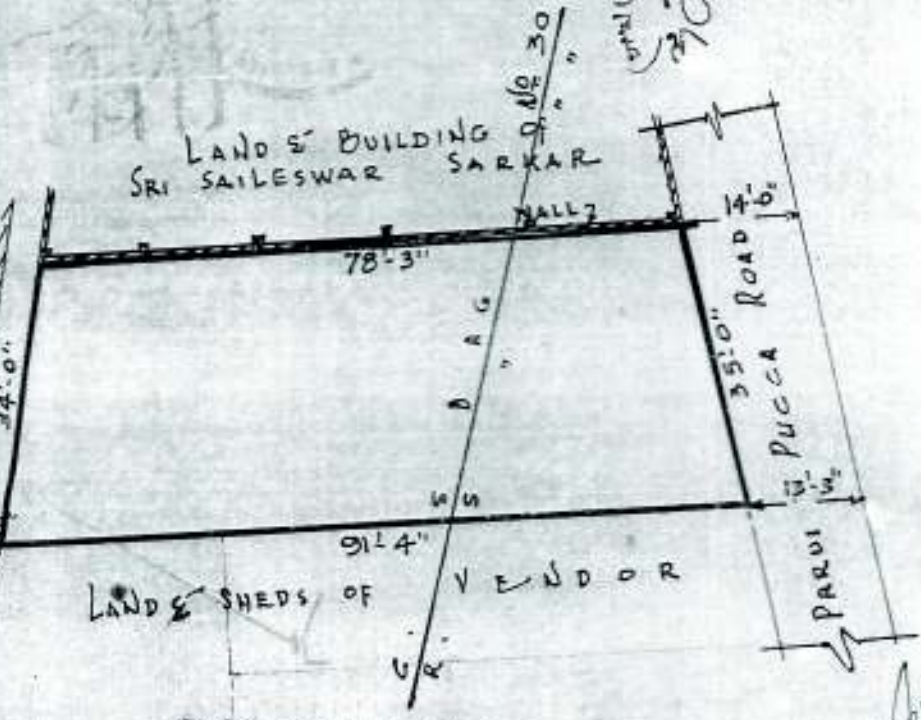
LAND PLAN FOR SM. GOURI RANI MUKHERJEE
