- 3. That the time period within which the project is completed by the Said Promoter is February, 2023 for Harbour (Tower 1H) & Glacier (Tower 1G). for the second Phase
- 4. That seventy per cent of the amounts realized by Promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
- 7.
