The Business of the Partnership shall be carried on at 114/89/7, I.C.Road, "Biswabina Aaprtment", ground floor, P.O. - Rahara, Police Station - Khardah, District- North 24 Parganas, Kolkata - 700 118. or at such other place or places as the partners shall from time to time determine. That the partnership business had already commenced on and from 18th day of December 2015. The Partnership shall be a PARTNERSHIP AT WILL. The Partners shall enter into engagements on behalf of the firm in the Firm's name only.

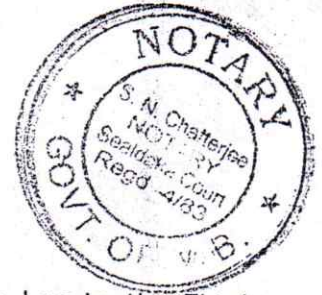
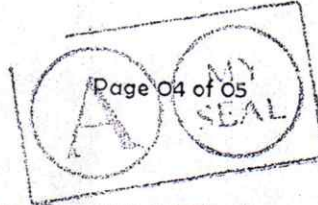

Nag shall liable to pay Rs. 1,00,000/- Rupees one Lac to the Third Partner of the said partnership Firm as his intial capital and the share of the Third partner shall reduce from 50% to 25% and the said reducing share of 25% of the Third party shall credit in favour of the New Partner Sri Debashis Nag. 05. BANK ACCOUNT :- That the partnership Firm shall maintain the existing bank account vide no. - 4248020000125 , over Bank of Baroda , Khardah Branch , and the same shall be operated by any two of the Partners jointly of the Firm.

All other clauses of the Original Partnership Deed dated 18.12.2015 shall be in operation and this Deed of Admission of new partner shall be treated as a part of the original Deed of Partnership dated 18.12.2015.

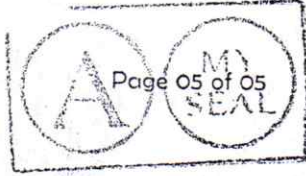
