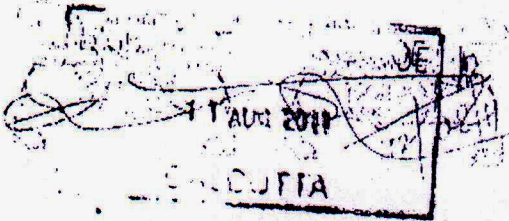

The Court : Despite substituted service only one of the respondents is represented.

In this partition and administration suit, a special referee was appointed who has circulated a report but has died. The Commissioner of Partition and Receiver has also expired. The Commissioner was required to effect sale of an immovable property at 5/1, Nerode Behari Mullick Road, Kolkata 700 006. The applicant seeks appointment of a Commissioner of Partition and Receiver in place and stead of the deceased Commissioner and Receiver.

Mr. S. S. Khanra, Adv. is appointed as Commissioner of Partition and Receiver at an initial remuneration of 1000 GMS (one thousand Gold Mohurs) to be shared by the parties in accordance with the shares declared in the preliminary decree. The appearing parties have consented to such appointment.

The further remuneration will be considered at a later date. The commissioner will immediately take steps to have the immovable property at Nerode Behari Mullick Road valued and to invite offers for sale thereof in such newspapers as the Commissioner may decide in consultation with the parties.

The sale of the immovable property will be subject to confirmation by Court for which any of the parties may apply. If the remuneration due to the Commissioner is not paid by any of the parties such remuneration will come out the share of such party out of the sale of the immovable property.
