- 8. That Promoter shall take all the pending approval on time, from the competent authorities.
- That Promoter has furnished such other documents as have been prescribed by the rules and regulations made the Act.
  - 10. That Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
