
**Terms and conditions**

3. That the licence is not transferable in respect of place or person.
4. That it only relates to the premises of part of the premises as defined above for which it is granted.
5. That it only relates to such trade as it is specified in it.
6. That no alteration be made in the area of the land or in the building to which the licence relates.
7. That the licence shall not store any place so because any article like petroleum product, any inflammable oil or spirit, any article of combustile nature etc. In excess of the quantity prescribed under Indian Petroleum Act, 1989 and shall take all precautionary measures to safegaurd against any incidence of fire.
