

**WHEREAS:**

- A) By a Development Agreement dated the 9<sup>th</sup> day of November, 2015, registered with District Sub-Registrar IV, South 24-Parganas, in Book No.I, Volume No.1604-2015, Pages 98081 to 98215, Being No.160407787 for the year 2015 (hereinafter referred to as the **said Development Agreement**), made between the Owners herein alongwith one Ashutosh Mukhopadhyay, Thyone Agri Products Pvt. Ltd., Eclair Infracon Pvt. Ltd., Etaka Realestate Private Limited, Ekaraj Buildcon Private Limited, therein collectively referred to as the Owners of the One Part and the Developer herein therein referred to as the Developer of the Other Part, the Owners therein had appointed the Developer therein to construct erect and commercially exploit by developing building/s upon All That the piece and parcel of land containing an area of 515 decimal, be the same a little more or less, lying and situate at Mouza Daulatpur, J.L. No.79, Mouza Sarmasterchak, J.L. No.17, both under Police Station Bishnupur, within the limits of Kulerdari Gram Panchayet and at Mouza Hanspukuria, J.L. No.20, Police Station Thakurpukur (formerly Behala), all in the District of South 24-Parganas more fully and particularly described in the First Schedule thereunder written (hereinafter referred to as the **said previous land**) on the terms and conditions recorded therein.
- B) The said Ashutosh Mukhopadhyay, who during his life time was a Hindu and Governed by the Dayabhaga School of Hindu Law, died intestate on the 10<sup>th</sup> day of May, 2017, leaving him surviving his widow namely, Smt. Bratati Mukhopadhyay, his only son namely, Siddhartha Mukherjee and only daughter namely, Shreya Mukhopadhyay who upon his death jointly inherited the entire share of Ashutosh Mukhopadhyay into or upon the said previous land in three equal proportion.
- C) The said Shreya Mukhopadhyay, out of her natural love and affection towards her brother namely, Siddhartha Mukherjee, made a free and absolute gift in respect of her undivided 1/3<sup>rd</sup> part or share in the entire share of Ashutosh Mukhopadhyay into or upon the said previous land by a Deed of Gift dated the 17<sup>th</sup> day of August, 2017, registered at the office of the Additional District Sub-Registrar, Bishnupur, South 24-Parganas in Book No. I, Volume No. 1613-2017, Pages 96693 to 96713, Being No.161304686 for the year 2017.
- D) The said Thyone Agri Products Pvt. Ltd., Eclair Infracon Pvt. Ltd., Etaka Realestate Private Limited, Ekaraj Buildcon Private Limited, were converted into the Limited Liability Partnership(s) on the 7<sup>th</sup> day of August, 2017, the 3<sup>rd</sup> day of August, 2017, the 7<sup>th</sup> day of August, 2017 and the 7<sup>th</sup> day of August, 2017, respectively and changed their names to "Thyone Agri Products LLP", "Eclair Infracon LLP", "Etaka Realestate LLP" and "Ekaraj Buildcon LLP" respectively. The certificates of such incorporation were issued by the Registrar of Companies, West Bengal.
- E) It was recorded in Clause 9.1 of the said Development Agreement that the Developer shall complete the said Project within a period of 60 (sixty) months

from the date of commencement of the construction on the said previous land with a grace period of 12 (twelve) months, both subject to force majeure.

F) It was also recorded in Clause 12.4 and 12.5 of the said Development Agreement that the Developer shall maintain a separate bank account to be known as Project Bank Account which shall be credited with the gross sales revenue and the Bank simultaneously after receiving the gross sales revenue from the Transferees/Purchasers shall transfer the proportionate revenue share of the Owners' Allocation to the Owners' nominated bank account after deducting the respective Service Tax and TDS.

G) It was agreed and recorded in Clause 21.10 of the said Development Agreement that the Developer shall consume and exploit floor area ratio (FAR) which was estimated at 2.5 available for the said previous land and on that basis the area allocable or saleable area to the Owners was coming to 1,36,000 sq. ft., be the same a little more or less.

H) It is further agreed and recorded in Clause 18.10 of the said Development Agreement that the Developer upon sanction of the plan can obtain project loan or advances from any bank or financial institution or anyone for the said project and for the said purpose shall be entitled to create mortgage or charge on the Developer's undivided share in the said previous land to comprise in the Complex or the Developer's allocation in the new buildings to be constructed thereon, in favour of any Bank by deposit of title deeds of the land to comprise in the Complex (equitable mortgage) or by executing simple mortgage deed or creating English mortgage, to secure project finance required by the Developer and further to execute any further document or documents in furtherance of the above objective, including executing letter evidencing deposit of title deeds, confirmation of title deeds, deliver the title deeds and to receive back the title deeds and further to acknowledge the debt and security in terms of Sections 18 and 19 of Limitation Act. Provided however the mortgage to be created by the Developer shall be limited to the Developer's allocation and shall not extend to the allocation of the Owners and the loan so obtained shall only be utilized for this project. For this purpose, the Owners have agreed to execute and/or join all deeds and documents in favour of any Banker (if required by the Banker) without raising any objection excepting that the Developer alone shall be liable and/or responsible for repayment of the loan together with the interest accrued due thereon and shall keep the Owners saved harmless and fully indemnified from and against all costs charges claims actions suits and proceedings arising there from including the Claim of the prospective purchasers of the Units.

I) Now the parties herein have mutually discussed and desired to alter certain terms of the said Development Agreement which are recorded herein.

**NOW THIS AGREEMENT WITNESSETH AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES** as follows:-

1. The said previous land as recorded in the said Development Agreement is presently revised as All That the piece and parcel of land containing an area of 460 decimal, be the same a little more or less, lying and situate at Mouza Daulatpur, J.L. No.79 and Mouza Sarmasterchak, J.L. No.17, both under Police Station Bishnupur, within the limits of Kulerdari Gram Panchayet, both in the District of South 24-Parganas more fully and particularly described in the **Schedule** hereunder written (hereinafter referred to as the **said land**).

2. The said Project shall be completed by the Developer within a period of 72 (Seventy Two) months instead of 60 (Sixty) months from the date of commencement of the construction on the said land with a grace period of 12 (Twelve) months, both subject to force majeure.

3. If the total allocable area calculated in the manner as aforesaid and available in the Owners' allocation, that is, 1,36,000 sq. ft. along with 136 numbers of car parking spaces, is increased at the time of sanction of the plan in such event the revenue to be generated for such additional area over and above the said 1,36,000 sq. ft. along with 136 numbers of car parking spaces allocable to the Owners shall be shared by and between the Owners and the Developer in the manner as follows:-

40% for the Developer  
60% for the Owners

4. The accounts between the parties with regard to sale of the project shall be gone into, taken and settled every month. The Developer shall furnish to the Owners a statement of monthly sales every month by the 7<sup>th</sup> day of the next month. Upon receipt of such statement the Owners shall settle the accounts for that month with the Developer.

5. After the settlement of the accounts of monthly sales, the Developer shall pay the respective revenue share of the Owners' Allocation to the Owners by the 10<sup>th</sup> day of the next month.

6. The Developer shall inform the Owners in writing before execution of conveyance(s) of the constructed spaces in terms of said Development Agreement to be constructed on the said land or part thereof and shall provide photocopies of the same upon execution thereof.

7. The Developer shall have the right and authorities to arrange for financing of the project (**Project Finance**) from any Banks and/or Financial Institutions for construction and development of the project upon such terms and conditions as may be applicable. 
