W H E R E A S:

A) Akhil Kumar Naskar was seized and possessed of and/or otherwise well and sufficiently entitled to All That the piece and parcel of land containing an area of 88 (eighty eight) decimal, be the same a little more or less, lying situate at Mouza Sarmasterchak, J.L.
