- Representations and Warranties Regarding Title: The Vendors have made 5.1the following representations and given the following warranties to the Purchaser regarding title:

- 8.1, Salient Terms: The transfer being effected by this Conveyance is:
- 8.1.1 **Sale:** a sale within the meaning of the Transfer of Property Act. 1882.
