- 5. Background, Representations, Warranties and Covenants

- 5.1.2 Ownership of First Property: Pursuant to the above, Jiyadali Mallik(Vendor No.3.1 herein above) became the sole and absolute owner of the First Property, out of Jiyadali's Property, comprised in the Said Property, free from all encumbrances.
- Ownership of Jayeda's Property: Jayeda Bibi alus Jayeda Mallik is the recorded and absolute owner of land classified as sali (agricultural)measuring 12.5 (twelve point five) decimal, more or less, out of 25 (twenty five) decimal, being a portion of R.S./L.R. Dag No. 36, recorded in L.R. Khatian No. 2357, Mouza Hariharpur, J.L. No. 11, Police Station Baruipur, within the jurisdiction of HGP, Sub-Registration District Baruipur, District South 24 Parganas (Jayeda's Property), free from all encumbrances.
- 5.1.4 Ownership of Second Property: Pursuant to the above, Jayeda Bibi alias Jayeda Mallik(Vendor No.3.2 herein above) became the sole and absolute owner of the Second Property, out of Jayeda's Property, comprised in the Said Property, free from all encumbrances.

- 8.1.4 Together with All Other Appurtenances: together with all other rights the Vendors have in the Said Property and all other appurtenances including but not limited to customary and other rights of easements for beneficial use of the Said Property.




