

- 5.1.3 Ownership of Jayeda's Property: Jayeda Bibi alias Jayeda Mallik is the recorded and absolute owner of land classified as sali (agricultural) measuring 12.5 (twelve point five) decimal, more or less, out of 25 (twenty five) decimal, being a portion of R.S./L.R. Dag No. 36, recorded in L.R. Khatian No. 2357, Mouza Hariharpur, J.L. No. 11, Police Station Baruipur, within the jurisdiction of HGP, Sub-Registration District Baruipur, District South 24 Parganas (Jayeda's Property), free from all encumbrances.






