5. Background, Representations, Warranties and Covenants

- 5.1.3 **Absolute Ownership of Vendors:** In the circumstances mentioned above, the Vendors have become the undisputed and absolute owner of the Said Property, free from all encumbrances.



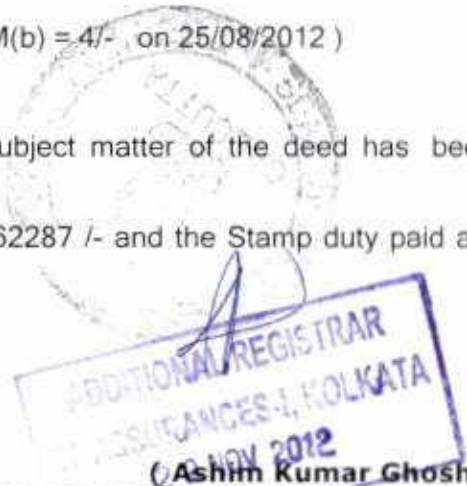


