4. Subject Matter of Conveyance

4.1 Said Property: Land classified as peyam bagan (orchard) measuring 14 (fourteen) decimal [equivalent to 8.4848 (eight point four eight four eight) cottah], more or less, out of 42 (forty two) decimal, being a portion of R.S./L.R. Dag No. 31, recorded in L.R. Khatian No. 1261, Mouza Hariharpur, J.L. No. 11, Police Station Baruipur, within the jurisdiction of Hariharpur Gram Panchayet (HGP), Sub-Registration District Baruipur, District South 24 Parganas, more fully described in the Schedule below and the said R.S./L.R. Dag No. 31 being delineated and demarcated on the Plan annexed hereto and bordered in colour Red thereon (Said Property) together with all title, benefits, easements, authorities, claims, demands, usufructs, tangible and intangible rights of whatsoever or howsoever nature of the Vendors in the Said Property and appurtenances and inheritances for access and user thereof.

5. Background, Representations, Warranties and Covenants

- 5.1 Representations and Warranties Regarding Title: The Vendors have made the following representations and given the following warranties to the Purchasers regarding title:

- Demise of Sachindra Nath Manna: Sachindra Nath Manna, a Hindu, govern by the Dayabhaga School of Hindu Law, died intestate leaving behind him surviving his 2 (two) sons, namely, Biren Manna and Ramen Manna, his 4 (four) daughters, namely, Lakshmi Pramanik, Bithi Pramanik, Sathi Pramanik and Iti Nath, as his only legal heirs and heiresses (collectively Legal Heirs Of Sachindra Nath), who jointly and in equal shares inherited the right, title and interest of Late Sachindra Nath Manna in the Said Property, free from all encumbrances.
- Sale to Vendors: By a Deed of Conveyance in Bengali Language (Kobala) dated 22ml May, 2006, registered in the Office of Additional District Sub-Registrar, Baruipur, in Book No. 1, CD Volume No. 25, at Pages 3941 to 3953, being Deed No. 8185 for the year 2012, Legal Heirs Of Sachindra Nath jointly sold, conveyed and transferred the entirety of the Said Property to the Vendors, free from all encumbrances and for the consideration mentioned therein.
- 5.1.4 Absolute Ownership of Vendors: In the circumstances mentioned above, the Vendors have become the undisputed and absolute owner of the Said Property, free from all encumbrances.
- 5.2 Representations, Warranties and Covenants Regarding Encumbrances: The Vendors represent, warrant and covenant regarding encumbrances as follows:
- No Acquisition/Requisition: The Vendors have not received any notice from any authority for acquisition, requisition or vesting of the Said Property and declare



- that the Said Property is not affected by any scheme of the Panchayet Authority or Government or any Statutory Body.

- No Encumbrance by Act of Vendors: The Vendors have not at any time done or 5.2.3 executed or knowingly suffered or been party or privy to any act, deed, matter or thing, including grant of right of easement, whereby the Said Property or any part thereof can or may be impeached, encumbered or affected in title.
- Right, Power and Authority to Sell: The Vendors have good right, full power, 5.2.4 absolute authority and indefeasible title to grant, sell, convey, transfer, assign and assure the Said Property to the Purchasers.

No. 11, Police Station Baruipur, within the jurisdiction of HGP, Sub-Registration District Baruipur, District South 24 Parganas, the said R.S./L.R. Dag No. 31 being delineated and demarcated on the Plan annexed hereto and bordered in colour Red thereon together with all title, benefits, easements, authorities, claims, demands, usufructs, tangible and intangible rights of whatsoever or howsoever nature of the Vendors in the Said Property and appurtenances and inheritances for access and user thereof, free from all encumbrances.
- 7.2 Total Consideration: The aforesaid transfer is being made in consideration of a sum of Rs.19,37,209/- (Rupees nineteen lac thirty seven thousand two hundred and nine) paid by the Purchasers to the Vendors, receipt of which the Vendors hereby as well as by the Receipt and Memo of Consideration hereunder written, admit and acknowledge.

- 8.1.3 Free from Encumbrances: free from all claims, demands, encumbrances, mortgages, charges, liens, attachments, lis pendens, uses, wakf, trusts, prohibitions, Income Tax attachments, financial institution charges, statutory prohibitions, acquisitions, requisitions, vestings, bargadars and liabilities whatsoever or howsoever made or suffered by the Vendors or any person or persons having or lawfully, rightfully or equitably claiming any estate or interest therein through, under or in trust for the Vendors or the Vendors' predecessors-in-title.
- 8.1.4 Together with All Other Appurtenances: together with all other rights the Vendors have in the Said Property and all other appurtenances including but not limited to customary and other rights of easements for beneficial use of the Said Property.


