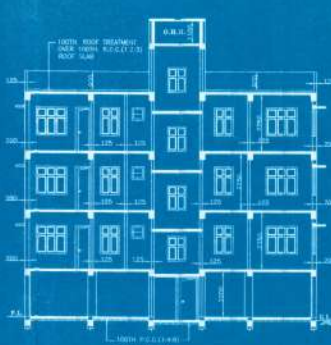




FRONT ELEVATION

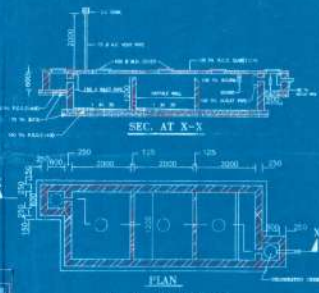


SECTIONAL VIEW AT A-A'

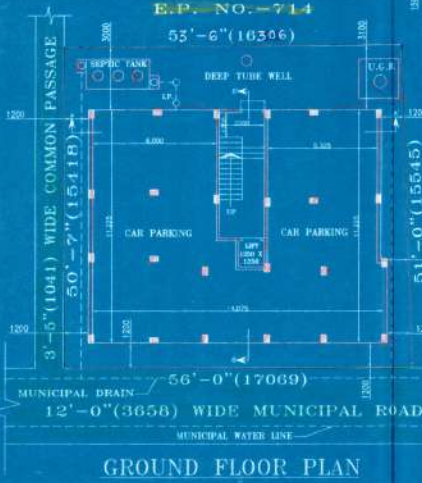
SEPTIC TANK DETAILS



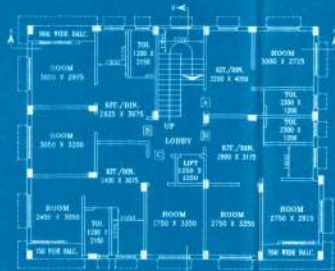
DETAILS OF SEMI U.G. WATER RESERVOIR



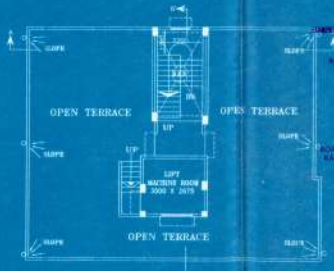
PROP. SITE PLAN
