




#### WHEREAS

Majumder Road (Math Bari), Post Office – Haltu, Police Station – Kasba, Kolkata – 700 078, the Owners as aforesaid do hereby nominate, appoint and constitute, MR.VIPIN BHIMANI AND/OR MR. NITIN BHIMANI both sons of Late V. L. Bhimani, by caste – Hindu, by occupation – Business, both of 82, Sarat Bose Road, Front Block, Kolkata - 700 026, either solely or jointly to be our true and lawful attorney for and on our behalf and in our names, place and stead at our cost do the following acts, deeds, matters and things at our costs that is to say.:-

- To apply for and obtain sanction of the building plans from the Kolkata Municipal Corporation and / or any other authorities and to sign and execute any such papers documents instruments that may be required in this regard.
- To sign, execute and submit all applications maps plans specification and Obtain the same thereof upon sanction in respect any new plan and/or any Modification or alterations thereafter upon the building plans sanctioned by the Kolkata Municipal Corporation and to sign and execute and submit any plan papers and documents and perform all the formalities and obligations as may be required or necessary from time to time.
- To pay fees to obtain sanction and other records permission and/or consents from the necessary authorities as be necessary or required for modification, alteration and / or sanction of the plan and / or any utility serving and / or concerning the said premises and also to sign other documents as may be required by the authorities from time to time.



- 4. - 6. To appear for and represent us before all authorities including those under B.L.& L.R.O. and The Kolkata Municipal Corporation for mutation, fixation and /or finalization of the annual valuation of the Said share of the property and for that to sign execute and submit necessary papers and documents and to do all other acts, deeds and things as the said Attorneys may deem fit and proper.
- 7. - 8. 




