WHEREAS:

- A. By an Indenture dated 11th March, 2010, registered with the District Sub-Registrar-I, Alipore, South 24 Parganas, in Book No. I, CD Volume No. 4, Pages 1201 to 1219, Being No. 00810 for the year 2010 (hereinafter referred to as the "Said Indenture"), the Vendors herein sold, transferred and conveyed in lieu of valuable consideration in favour of the Purchasers herein, All That the piece and parcel of sali land admeasuring 0.5625 decimals more or less (equivalent to 5 chittacks 20 sq.ft. more or less) comprised in a portion of R. 
