

- 1. That one Tirupati Properties, a partnership firm, Land Owner of the proposed project, having its registered office at Meridian Plaza, 209,C.R.Avenue,4th Floor, P.O.- Bedon Street, P.S.-Girispark, Kolkata-700006, District- Kolkata, has legal title to the land on which the development of the proposed project is to be carried out and a legally valid authentication of the title of such land along with an authenticated copy of the agreement between such owner and the promoter for development of the real estate project is enclosed herewith.
