## REPORT ON TITLE

**OWNER :** **JAMAL UDDIN SEIKH alias SK. JAMAL UDDIN**, son of the Late Abdul Seikh, residing at Village Majherpara, Police Station Sonarpur, District South 24 Parganas.

### 1. DESCRIPTION OF THE LAND :

**ALL THAT** piece and parcel of land containing an area of 11 Sataks, be the same a little more or less, situate lying at Mouja Kumrakhali J.L. No.48 Revenue Survey No.131 Police Station Sonarpur in the District of South 24-Parganas comprised in :

### 4. DEVOLUTION OF TITLE :

One Sultan Sardar was lawfully seized and possessed of or otherwise well and sufficiently entitled to amongst others All That the piece and parcel of land containing an area of 23 Sataks, be the same a little more or less, situate lying at Mouja Kumrakhali J.L. No.48 Revenue Survey No.131 Police Station Sonarpur in the then District of 24-Parganas comprised in :

B. The said Sultan Sardar died intestate leaving him surviving his two sons namely Hossain Ali Sardar and Ali Mohammad Sardar and two daughters namely Balu Bibi alias Banu Bibi and Hasina Khatun Bibi as his surviving legal heirs, heiresses and legal representatives who inherited amongst others All That the said mother land in their respective proportions.

C. By a Bengali Kobala (Deed of Sale) dated the 2<sup>nd</sup> day of May 1967 made between the said Hossain Ali Sardar therein referred to as the Vendor of the One Part and the said Jamal Uddin therein referred to as the Purchaser of the Other Part and registered with the Sub-Registrar Baruipur in Book No.I Volume No.63 Pages 254 to 256 Being No.3756 for the year 1967, the Vendor therein for the consideration therein mentioned granted, transferred, conveyed, assured and assigned unto and in favour of the Purchaser therein amongst others All That his undivided part or share in the said mother land containing an area of 7 Sataks, be the same a little more or less, more fully and particularly described in the Schedule thereunder written, absolutely and forever.

D. By another Bengali Kobala (Deed of Sale) dated the 7<sup>th</sup> day of July 1967 made between the said Balu Bibi alias Banu Bibi therein referred to as the Vendor of the One Part and the said Jamal Uddin therein referred to as the Purchaser of the Other Part and registered with the District Registrar Alipore in Book No.I Volume No.169 Pages 104 to 106 Being No.5962 for the year 1968, the Vendor therein for the consideration therein mentioned granted, transferred, conveyed, assured and assigned unto and in favour of the Purchaser therein amongst others All That her undivided part or share in the said mother land containing an area of 3½ Sataks, be the same a little more or less, more fully and particularly described in the Schedule thereunder written, absolutely and forever.

E. The said Jamal Uddin recorded his name in the office of the Block Land and Land Reforms Officer, Sonarpur and remained in peaceful possession of All That the piece and parcel of land containing an area of 11 Sataks, be the same a little more or less, situate lying at Mouja Kumrakhali J.L. No.48 Revenue Survey No.131 Police Station Sonarpur in the District of South 24-Parganas comprised in :

F. Thus the said Jamal Uddin became seized and possessed of or otherwise well and sufficiently entitled to All That the said land free from all encumbrances, charges, liens, lispendens, attachments, acquisitions, requisitions and trusts whatsoever nature.

##### **5. RESULT OF THE SEARCHES :**

From the searches made as aforesaid:

a] It appears that excepting as aforesaid no transaction was found in respect of the said land in any of the aforesaid registration offices during the period for which searches were made.

However, it transpires that some pages of the Volumes as available in the office of the Additional District Sub-Registrar Sonarpur for the years 1979 to 1982, 1984 to 2002 are found to be partly torn; some pages of the Volumes as available in the Office of District Registrar Alipore for the years 1979 to 1987, 1991, 1992, 1996, 1998, & 2000 to 2002 are found to be partly torn; some pages of the Volumes as available in the office of the Registrar Assurances Kolkata for the years 1980, 1984 and 1997 are found to be damaged and some pages of the Volumes for the year 1994 and 1995 are partly torn and the volume for the year 1999 is found torn.

b] It also appears that no money suit, title suit, money execution case, title execution case has been filed in the aforesaid Courts touching the said land.

c] It further appears from the searches made at the Office of The Land Acquisition Collector, Alipore that the said land has not been vested in the State of West Bengal or acquisitioned by the said Land Acquisition Collector, South 24Parganas at Alipore.

d] It transpires that the said land has not been acquired by KMDA for the purpose of any project.

e] It also transpires from the searches made at the Office of the P.W. (Roads) Directorate, Highway Service Division No.3, Government of West Bengal, Establishment Branch, South 24Parganas, Alipore that the said land has not been acquired by the P.W. (Roads) Directorate for the purpose of any project.



f) It further transpires from the Dag Information supplied to us by the client from the Office of the Block Land and Land Reforms Officer, Sonarpur, District South 24 Parganas that the predecessor of the Owners abovenamed had mutated his name in respect of the said land in the records of Land Revenue Department and new L.R. Khatian being No.480 was opened in his name.

g) We caused advertisements to be published in Telegraph and Ananda Bazar Patrika. No objection was received on the title to the said land.

#### 6. CERTIFICATION :

On perusal of the aforesaid documents and based on the aforesaid searches, we are of the opinion and we certify that the said land in question appears to be marketable and the said Jamal Uddin has title thereto as aforesaid.
