- That the time period within which the project shall be completed by promoter is 3. 30/10/2021.
- The seventy per cent of the amounts realized by promoter for the real estate project 4. from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- That the amounts from the separate account, to cover the cost of the project, shall be 5. withdrawn in proportion to the percentage of completion of the project.
