1. That promoter **GANGULY HOME SEARCH PVT. LTD.** have/has a legal title to the land on which the development of the proposed project is to be carried out.

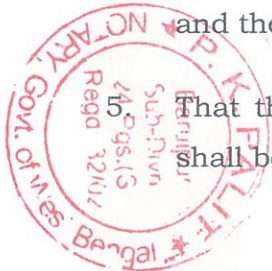
