Affidavit cum declaration of Mr. Rajib Dey, Proprietor of the land owner/promoter (Sree Ram Construction) of the proposed project ;



1. I have a legal title to the land on which the Development of the proposed project is to be carried out

a legally valid authentication of title of such land along with an authenticated Copy of the Sale Deed of the real estate project is enclosed herewith.
2. That the project cost shall be funded by the own source of promoter for constructing 13 units of flat and 12 car parking at the land site at 26 C D.P.P Road .
3. That the time period within which the project shall be completed by the Promoter is 31<sup>st</sup> March, 2020.
4. That seventy percent of the amounts realised by me/ land owner/promoter for the real Estate project from the allottees, from time to time, shall be deposited in a Separate account to be maintained in a scheduled bank to cover the cost of Construction and the land cost and shall be used only for that purpose.
5. That the amounts from the Separate account, to cover the cost of the Project, shall be withdrawn in proposition to the percentage of completion of the project.
6. That the amounts from the separate account shall be withdrawn after it is Certified by an engineer, an architect and a chartered accountant in Practice that the withdrawal is in proposition to the percentage of Completion of the project that the promoter shall get the accounts audited Within six months after the end of every financial year by a chartered Accountant in practice, and shall produce a statement of accounts duly Certified and signed by such chartered accountant and it shall be verified During the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance With the proportion to the percentage of completion of the project.
7. That land owner/promoter shall take all the pending approvals on time, from the Competent authorities.
8. That land owner/promoter have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
9. That land owner/ promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any Grounds.
