AND WHEREAS in the above manner said Bhupen Saha, became the absolute owner of the schedule mentioned property but did not mutated his name in the record of B.L. & L.R.O. and still the name of said Jahangir Mandal, son of Akbar Ali is duly recorded in record of rights/parcha with respect to L.R. Khatian No. 719, J.L. No. 79, Mouza : Daulatpur, Police Station : Bishnupur, District : South 24 Parganas, relating to inter-alia land measuring about 30 decimals under Dag No. 728 ;

AND WHEREAS the Vendor is the lawful absolute owner and fully seized and possessed of and/or otherwise well and sufficiently entitled to All That the demarcated piece or parcel of Sali land measuring about 16.5 decimal out of 1.17 acres comprised in Dag No. 728, Khatian No. 719, under Mouza : Daulatpur, J.L. restrictions restrictive covenants executions acquisitions requisitions attachments vesting alignment easements liabilities and lispendens whatsoever AND the Vendor do hereby covenant with the Purchaser that the Vendor is the absolute and lawful owner of and well and sufficiently seized and possessed of and entitled to the said property and every part thereof free from all encumbrances and liabilities of whatsoever nature AND the Vendor do hereby covenant with the Purchaser that neither the Vendor nor any of his predecessors-in-title have at any time heretofore done or executed or knowingly suffered or been party or privy to any act deed matter or thing whereby or by reason whereof the said property hereby granted sold conveyed transferred assigned and assured or expressed or so intended to be was or is encumbered in title estate or otherwise or by reason whereof the Vendor may or can be prevented from granting selling conveying assigning and assuring the said property or any part thereof in the manner aforesaid AND THAT NOTWITHSTANDING any act deed or thing by the Vendor and/or any of his predecessors-in-title done executed or knowingly suffered to the contrary the Vendor at the time of execution of these presents is the absolute and lawful owners of and/or otherwise well and sufficiently seized and possessed of and entitled to the said property hereby granted sold conveyed transferred assigned and assured or expressed so to be and every part thereof for a perfect and indefeasible estate of inheritance without any manner of condition use trust or other thing whatsoever to alter defeat encumber or make void the same AND THAT NOTWITHSTANDING any such act deed or thing whatsoever as aforesaid the Vendor has now in herself good right and full and absolute power to grant sell convey transfer and assure the said property hereby granted sold conveyed transferred and assured or expressed so to be unto and to the use of the Purchaser in the manner aforesaid AND that the Purchaser shall and may at all times hereafter peaceably and quietly enter into hold possess and enjoy the said property and receive and take the rents issues and profits thereof without any lawful eviction interruption claim or demand whatsoever from or by the Vendor or any person or persons lawfully or equitably claiming from under or in trust for the Vendor or from under or in trust for any of his predecessors in title or any of them AND THAT the Purchaser shall be free


