No rain water pipe should be fixed or discharged on Road or Footpath. Drainage plan should be submitted at the Borough Engineer's Office and the sanction obtained before proceeding with the drainage work.

A suitable pump has to be provided i.e. pumping untreated water for the distribution to the flushing cisterns and urinals in the building unless surface water from street main is not available.

Before starting any Construction the site must conform with the plans enclosed and all specifications as proposed in the plan should be followed. The validity of the written permission to execute the work is subject to the above conditions.

Design of all Structural Members including that of the foundation should conform to Standards specified in the National Building Code of India.

All Building Materials to be used & construction should conform to standards specified in the National Building Code of India.

Non Commencement of Enclosure Re-Extension within Two Year will Require Fresh Application for Sanction.
