4. That the time period within which the project shall be completed by the partnership firm within the December 2021.
5. That seventy percent of the amounts realized by the partnership firm for the real estate project for the allottees (proforma agreement for sale) from time to time shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
