INVENTORY OF IMMOVEABLE PROPERTY OF HIS HIGHNESS
THE MAHARAJA OF TRIPURA FURNISHED UNDER
ARTICLE III OF THE AGREEMENT DATED 9TH SEPTEMBER 1949

- (1) Ujjayanta Palace with all the buildings
within the compound walls Private
- (2) Tripura House, Calcutta "
- (3) Tripura Castle, Shillong Private
- (4) Nirmahal Kothi Private
- (5) Kunjaban House with compound State

Note:- A portion of the Kunjaban House is required for the occupation by the Chief Executive Officer of the State, but the remaining portion will be maintained by the State as a distinguished visitors' Guest House. His Highness' guests will have the prior right of occupation of this guest house.

- (6) Malanchabash House Private

(7) Stable This will be considered as the Ruler's private property till such time as a new garage is constructed by the State within the palace compound. If this is not constructed, the stables will remain with the Ruler as private property. His Highness will allow the use of such portions of it as are not required by the Ruler.

- (8) Old Guest House State
- (9) Brown's House State

(10) Khush Lands

(i) Resham Bagan (measuring about 6 drones)

11) Fruit and Vegetable Gardens upto Hathipara Lichi Bagan on either side of Shillong road, measuring about 135 drones.

111) Hatipara Sal Garden (measuring roughly about 50 drones)

(11) Chakla Reshmabad Zamindaris, situated in East Pakistan, along with the buildings, vacant places and rights appertaining to that Zamindari

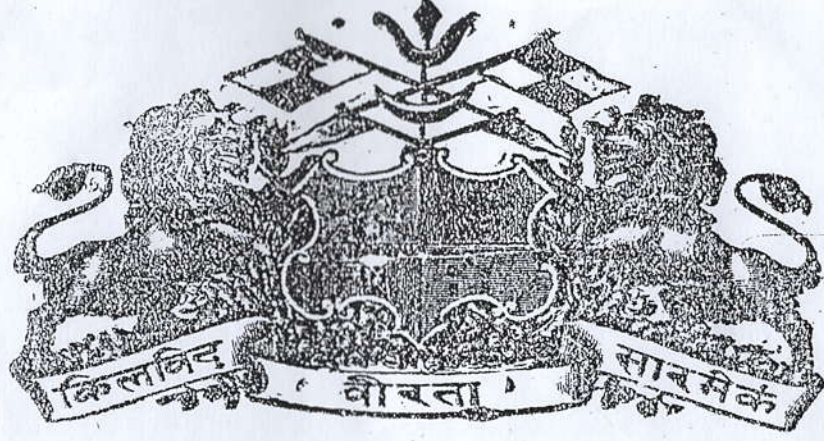
In connection with the agreement signed by Your Highness on behalf of His Highness the Maharaja of Tripura today ceding to the Dominion Government full and exclusive authority, jurisdiction and powers for and in relation to the governance of the Tripura States, I write to give an assurance to Your Highness on the following matters:-

- (1) Your Highness has discussed with me the inventory to be furnished under Article III of the Agreement. So far as immovable properties are concerned it was agreed that the properties in the list attached will be recognised as the Ruler's private property. Your Highness has to furnish the list of securities and cash balances, under Article III, by the 10th October 1949. As your Highness will notice, we have agreed to treat the Chakla Roshnabad Zamindari as the Ruler's private property.
- (2) The existing rights, privileges and dignities of the Ruler and the Rajmata have been specifically recognised under the Agreement. A Copy of the Memorandum which has issued to all the Rulers on the subject is enclosed for Your Highness' information.
- (3) The Ruler's exclusive shooting rights in areas to be specified will be recognised. Your Highness promised to send us a list of the areas which you would like to be earmarked for this purpose.
- (4) The allowance of Rs.5,000/- permonth fixed for Your Highness will continue to be paid during the lifetime of Your Highness.
- (5) The allowance of Rs. 1,500/- per month, sanctioned for each of the two princesses, will continue to be paid to them till the date of their marriage. Also, the sum of Rs. 1 lakh (Rs.50,000/- for each Princess) will be placed at Your Highness' disposal as Civil List Reserve Fund for the marriage of the two Princesses.
- (6) His Highness the Maharaja will continue to receive free supply of water and electricity on a scale not exceeding the present scale in the portions of the Ujjayanta Palace, which are occupied for the use of His Highness and his immediate family.
