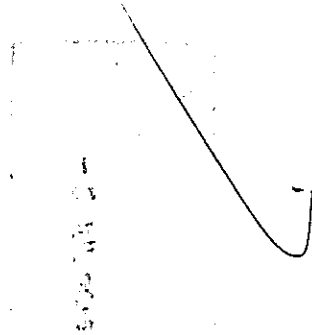
"**Parties**" shall mean collectively the Vendor and the Purchaser and "**Party**" means each of the Vendor and the Purchaser individually.

WHEREAS:-
