This is to certify that I have caused search through my clerk Mr A H Molla of the above mentioned Dag Numbers At Mouza Doharia in Index –II in connection with the Office of the Additional Registrar of Assurances-II, Kolkata during the period from 1967 to 2015, the Offices of the District Registrar, Alipur and Barasat, during the period from to 1967 to 2015 and the office of the Additional District Sub Registrar at Barasat for the period from 1967 to 2015 and during my searching period from the available records and documents of the above said offices and also in computer and on examination of the photocopies of the title deeds as well as other papers and documents supplied by the present owners, my report is as follows:

It appears from the photocopy of the deed of sale executed between Mrs. Waine Olga Williamson wife of Late Denisvarnon Williamson and Sri Tejoymoy Mitra son of Late Satish Chandra Mitra on 07/04/1967 and registered in the office of the then Registrar, 24 Parganas at Alipur vide Being No. 1575 for the year 1967 in Book No.1, Volume No.67, Pages from 100 to 103 that some Satish Chandra Paik and Ratan Chandra Paik seized and possessed a plot of land measuring 1(one) acre 27(Twenty seven) decimals togetherwith tree and tank on the said plot of land having Rayati Mokarari right and lying and situate at Mouza- Dohariagram, Paragana -Anwarpur, Touzi No.146 of Alipur Collectory, J.L. No. 45, Rev. Survey No. 132, Khatian No. 212, Dag No. 1321 and 1322 under P.S. and S.R. Barsat, District the then 7/24 Parganas having rayati right at an annual rent of Rs. 17/- under the landlords Balai Chand Biswas and Kanai Lal Biswas and said Golam Mandal & ors. Defaulted in payment of rent for which the landlords got a decree in Rent Suit No. 2022 of 1932 in 18 Munsiff at Barsat and purchase the same in auction sale and took possession of the same. Thereafter the landlords let out to their father Babu Hrishikesh Biswas for life a plot of land measuring 2.71 acres out of the aforesaid Danga land of 3.31 acres comprising in R.S. Dag Nos. 1317, 1319, 1320 & 1324 by a registered Deed of lease without having right to transfer his tenancy by sale or otherwise. Subsequently one Panchanan Mondal collusively and fraudulently took a patta in his favour purported to be executed by one Shova Mani Dasi who had no right, title and interest in respect of the said 2.33 acres of land out of the entire land. Said Hrishikesh Biswas surrendered the life tenancy in respect of the aforesaid land in favour of the landlords by a solenama filed in T.S. No. 38 of 1939 in 4th S.J. at Alipur. Thereafter the said landlords instituted a title suit being T.S. No.42 of 1943 in the 1st Court of Munsiff at Barasat against said Panchanan Mondal along with others as said Panchanan Mondal asserted possession in the said lands. Said Panchanan Mondal died during the pendency of the suit and his heirs were duly substituted in his place. Said heirs of Panchanan Mondal, since deceased surrendered their interest in the said 2.33 acres of land stated in the aforesaid patta dated 31/3/1938 for letting out to the said Panchanan Mondal and the said suit was decreed against the heirs of Panchanan Mondal in terms of the said Compromise on 15/03/1940.
