This has a reference to your application submitted on 03/12/2014 for environmental clearance for the proposed residential complex at premises no. 24, Diamond Harbour Road, Ward No.144 of Kolkata Municipal Corporation, PS. Thakurpukur, Dist.24 Parganas (S) Kolkata - 700 104 and presentation made by you before SEAC on 04/02/2015.

Based on your application for environmental clearance and presentation made by you, SEAC in its meeting dated 04.07.2015 has recommended a list of stipulated conditions for the up coming project.

In addition to the SEAC's observations, it has been decided by SEIAA in the meeting dated 30.09.2015 that the following issues are to be addressed appropriately while submitting sanctioned building plan for obtaining environmental clearance.

- At least 15 KW of solar power to be generated and utilized.
- 2. Water meter to be installed at every inlet point of fresh water uptake, STP inlet & outlet including discharge point of treated water and regular records to be maintained.
- Provision for backup power for operation of STP during power failure should be made.
- Dedicated car washing area to be earmarked and car washing water to be collected and treated in STP as proposed.
- Recycling of treated waste water to be maximized by way of dual plumbing.
- Microclimatic studies to be completed as per the indicative guidelines for high-rise building including power consumption per unit ground coverage, fraction of covered area that can be illuminated by natural lighting only during normal sunny day and power required for air conditioning of the buildings and heat released by air conditioning machines at each building.

You are requested to prepare the construction plan incorporating those conditions before submission of the same for building plan approval. The sanctioned building plan may kindly be submitted in the secretariat of SEAC at Paribesh Bhavan, Salt Lake. The SEIAA shall consider the case only when it is ensured that the conditions listed in the enclosure have been properly addressed in the building plan.

The State Level Expert Appealsal Committee, West Bengel, hereby, proposes the stipulated conditions for environmental clearance as per the provision of Environmental Impact Assessment Notification 2006 and the subsequent amendments, on the basis of above mentioned features along with other details submitted to SEIAA, subject to strict compliance of the terms and conditions (whichever applicable at building sanction stage) mentioned below.

Part A - SPECIFIC CONDITIONS

L. Construction Phase Facility of labourers during construction:

Provision of drinking water, wastewater disposal and solid waste management should be easured for

labour camps. Water usage during construction should be optimized to avoid any wastage.

ii. Proper sanitation facilities should be provided for construction workers to ensure environmental sanitation. Sewage generated from the areas occupied by the construction labourers have to be directed into the existing sewage drain of the area. In case of non availability of the sewer system, an ensite treatment system has to be provided.

in. The scaffolds, stars and platforms for construction works and the workers must be secured as far as

possible to prevent any accident.

iv. Health and safety of the workers thould be ensured during construction. Personnel protective equipment like shoes, helmets, earmuffs, earplugs etc. should be provided to the workers. For vibration control damped tools must be used and the number of hours that a worker uses them must be lumited. The Management must ensure that the workers put them while doing work that needs such protection, if any.

Rest and convenience shelter for workers with creche facility, if required, particularly for women, must

be provided with proper tollet facilities.

Steps to avoid disturbance during construction-

All the topsoil excavated during construction activities should be under cover/stored by retaining walls for use in horticulture / landscape development within the project site. Adequate erosion and sediment control measures to be adopted before ensuing construction activities.

ii. Prior permission should be obtained from the competent authority for demolition of the existing structure, if any. Wests recycling plans should be developed for prior to beginning of demolition and construction activity. The plans should identify wastes to be generated and designate handling,

recycling and disposal method to be followed,

III. Disposal of muck including excavated material during construction phase should not create any adverse effects on the neighbouring communities and disposed off taking the necessary precautions for general safety and health aspects.

iv. Diesel generator sets during construction phase should have acoustic enclosures and should conform

to E(P) Rules prescribed for air and noise emission standards.

v. Vehicles / equipment deployed during construction phase should be in good condition and should conform to applicable air and noise emission standards and should be operated only during nonpeaking bours.

el. Ambient noise levels should conform to residential standards both during day and night. Fortnightly moritoring of ambient air quality (SPM, SO2 and NOx) and equivalent noise levels should be ensured

during construction phase,

vii. Construction spoils including bituminous material and other hazardous materials including oil from construction equipments must not be allowed to contaminate watercourses and the dump sites for such material must be secured so that they should not leach into the ground water. If necessary, oil trap should be installed where there is deployment of heavy machineries.

Only essential operations, if any, may be carried out for a limited period during nighttime,

The proponent must ensure that no driven piles shall be proposed for this project, if there is any major settlement in the surrounding areas.

zi. 15m-screen and adequate sprinkler arrangement shall be provided. Care should be taken to keep all craturial storages adaquately covered and contained so that they are not exposed to winds.

sii. Use of Ready-Mix concrete is recommended for this project.

xiii. Adequate measures to be adopted in avoid westage of water for curing of coucrete structures.

viv. Adequate mitigative measures about 50 adopted to control dust emissions, noise and vibrations from construction activities. Vehicles and construction machineries should be properly maintained. Vehicles should conform to Poliution under control (PUC) norms.

4. Locally available materials with less transportation cost should be used preferably.

rvi. Promotion of use of cleanor fuel and fuel quality improvement should be done. Excessive energy consumption and fuel usage stould be avoided.

tval. Accumulation / stagnation of water should be avoided pyonsure vector control.

Selection of materials for better energy efficiency:-

Use of energy efficient construction materials should be ensured to achieve the desired thermal comfort. Design layout should ensure adequate solar access and ventilation. Proper planning and window design

for daylight integration should be considered.

iii. Fly Ash is to be used for construction as per Notification No. S.C. 763(E) dated 14.09.1999 amended vide Notification No. S.D. 979(E) dated 27.8.2003 and S.O. 2804(E) dated 03.11.2009 of the Ministry of Environment & Forests, Govt. of India.

iv. Construction should conform to the requirements of local seismic regulations. The project proponent should obtain permission for the plans and designs tockeding structural design, standard and

specifications from concerned authority.

Construction technologies that require less material and possess high strength should be adopted. Materials with low embodied energy and high strength should be used preferably.

vi. The building will be constructed and provisioned to use natural sunlight to the maximum during the day time, during use.

vil. Use of alternate building materials and alternate construction techniques should be considered apart

from the conventional materials and methods. Use of bollow unit masuary should be considered.
viii. Use of energy efficient lighting systems e.g. High Pressure Sodium Vapour (HPSV) Lamps, LED etc. should be promoted. Solar energy should be used for outdoor lighting. Adequate no. of solar lights should be installed for external lighting as per norms. All common area lighting will be LED system.

ix. Solar water heating arrangement will be done for water heating .

Passive solar cooling to be incorporated in building dasign. Buildings should be oriented for ensuring natural ventilation and daylighting.

Proper tosulation of roof should be provided to achieve desired thermal condort. Use of light coloured, reflective roofs having an SRI (solar reflectance index) of 50% or more should be incorporated.

xii. Use of high albedo or reflective pavements to keep perlong lots, pavements and inside roads cool should be incorporated. xiii. Guidelines to the occupants should include usage efficiency measures such as energy efficient lighting

The water body is to be kept in natural conditions without disturbing the ecological habitat. The area & location of the water body should be incorporated in the sanctioned building plan.

Plantation Proposal:-

The unit should strictly abide by The West Bengal Trees (Protection and Conservation in Non-Porest Areas) Rules, 2007. The proponent should undertake plantation of trees over at least 20% of the total

No tree can be felled without prior permission from the Tree Cutting Authority constituted as per the West Bengal Trees (Protection and Conservation in Non-Forest Areas) Act, 2006 and subsequent rules.

in. The proposent should plant at least 120 trees as proposed in addition to the existing trees. The landscape planning should include piantation of native species. The species with heavy foliage, broze leaves and wide concept cover are desirable. Water intensive and/or invasive species should not be used for landscaping.

iv. Provision for Roof Top Gardening is mandatory.

Water supply:-

Water requirement during construction phase shall be met from XMC supply. Ground water should not he abstracted without prior permission from the compotent authority as per the West Bengal Ground Water Resources (Management, Control and Regulation) Act, 2006.

Sewage Treatment Plant:-

As per the proposal submitted by the proponent weste water shall be treated in septic tank to sonk pit. Construction waste water to be collected in sedimentation trap with adequate refention time and to be reused.

Storm water Management & Mitigation of Heat Island Effects-

- Imperviousness of the site shall not exceed the NBC (National Building Code 2005) standards for imperviousness factor applicable to different types of area.
- Total paved area of site under parking, roads, paths or any other use should not exceed 25% of the site
- iii. Minimum 50% of paved area on site should have pervious paving or shaded under vegetation or to poed with finish having solar reflectance of 0.5 or higher.
- iv. Adequate storm water drainage network to be designed for the project without disturbing the surrounding settlements. Storm weier management plan should be implemented so as to prevent sudden discharge of excessive volumes of storm water to the receiving waters thus reducing the shock
- load on the drainage system and impact on receiving water body.

- I. The proposest must follow the Rainweter Harvesting Guidelines of the State Expert Appraisal Committee (SEAC) available in the website (http://www.wbpcb.gov.in).
- il. The proponent must collect rainwater from roof-top catchments and reuse for various purposes after necessary cleaning. Adequate recention time and storage provisions should be provided for harvesting rainwater.
- iii. Adequate firefighting storage should be provided as per norms.

Municipal Solid Waste Management :-

i. Adequate provision shall be made for storage and segregation of solid waste and adequate means of access shall be provided.

Transport Management: -

- Both internal and external traffic planning and management should be adequate to ensure uninterrupted traffic movement in the area during construction as well as operation phase.
- ii. The design of service road and the entry and exit from the project area should conform to the norms & standards of competent authority for traffic management. Bell mouth type arrangement should be made at the entry & exit. Proper traffic management plan should be adopted in consultation with Trainc authorities.
- iii. Clarified Wastewater will be used for sprinkling water on the unpaved internal roads on a regular basis.

- All mandatory approvals and permission as required from Director of Explosives, Fire Department etc. should be obtained.
- Provision of Effective Controls and Building Management Systems such as Automatic Fire Alarm and Fire Detection and Suppression System etc. must be ensured.
- ili. Efficient management of indoor air quality must be ensured for health and safety of the users.
- Adequate measures to be adopted for water conservation during construction and operation stage. Use of efficient irrigation equipment, evaporative cooling unit in air-conditioning system etc should be considered.
- Rest room facilities should be provided for service population.
- Adequate access to fire tenders should be provided.

Water requirement during operation phase shall be met from KMC supply. Ground water should not be abstracted without prior permission from the competent authority as per the West Bengal Ground Water Resources (Management, Control and Regulation) Act, 2005.

Use of water meter conforming to ISO standards should be installed at the inlet point of water uptake to monitor the daily water consumption. Use of water efficient devices / fixtures and appliances should be promoted. Installation of duel flushing system should be considered to conserve water.

iii. The proponent must practice rainwater barvesting on regular basis,

Sowage Treatment Plant:-

- i. As per the proposal submitted by the proposent, waste water shall be treated in STP. Treated waste water shall be partly reused for dual flushing,landscaping; internal road and povement cleaning etc. and rest will be discharged to KMC sewer.

Emission from Diesel Generator Set: -

Noise burriers will be provided at appropriate locations so as to easure that the noise levels do not exceed the prescribed standards. Diesel generator sets should be provided with integral acoustic. enclosure at the manufacturing stage itself as per CPCB norms.

The stack height and emissions from D.G. sets should conform to the norms of Control Poliution. Control Board. The certification of space design for DG sets should be done by competent authority.

Ensure Energy Efficiency:-

Use of energy efficient construction materials to achieve the desired thermal comfort should be incorporated. The desired level of R and U factors must be achieved. U factor for the top roof should not exceed 0.4 Watt/sq.m/degree centigrade with appropriate modifications of specifications and building technologies. The provisions of National Building Code 2005 should be strictly followed.

Use of energy efficient electrical systems should be promoted. High efficiency lamps with electronic

ballasts should be used.

- III. Energy hefficient Motors and properly rated Transformers should be installed. Manufacturer's certificate to this effect shall be obtained and kept on record. Back up power supply should be based on
- The power cabling shall be adequately sized as to maintain the distribution lesses not to exceed 1% of the total power usage. Record of trensmission losses shall be maintained. The proponent shall install permanent electrical metering to record demand (kVA), energy (kWh) and total power factor.

Transport Management: -

Use of public mode of transportation should be promoted. Use of the least polluting type of transportation should be promoted. Adequate parking space should be provided as per norms.

ii. Pathways should be covered or shadowed by tree canopy as far as practicable. Transport system should be such that traffic will be calm in neighbourhoods. Traffic within the project site should be restricted by regulation. Adequate vertical and horizontal clearances of overhead electric power and telecommunication lines should be provided.

Solid Waste Management:-

The proponent should abide by the Municipal Solid Wastes (Management and Handling) Rules, 2000. The proponent must develop the Solid Waste Management and Disposal Scheme ensuring storage and segregation of biodegradable and non-biodegradable wastes. The solid waste is to be disposed off in consultation with concerned authority.

The proponent shall install easite compost plant for treatment of biodegradable part of Municipal Solid.

Waste. Sufficient space for installation of onsite compost plant should be provided and operation of the compost plant considering full occupancy of the apartments i.e. the capacity of gerbage disposal unit

should be aslected accordingly.

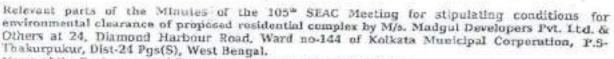

These supulations would be enforced among others under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention and Control of Pollution) Act, 1981, the Environment (Protection) Act, 1986, the Public Liability (Insurance) Act, 1991 and EIA Notification 2006 including the amondments and clarification circulars.

10. The final Environmental Clearance shall be accorded by the State Environmental Impact Assessment Authority, West Bengal after submission of master site plan of the whole project sanctioned by the concerned municipality incorporating all the salient features of the stipulated conditions for environmental clearance and necessary documents and consideration of the same by the State Lavel Expert Appraisal Committee, West Bengal. The area statement as well as detailed building profile, parking spaces etc., as proposed in the salient features, should be clearly mentioned in the sanctioned Master Plan.
