W - H - E - R - E - A - S :

- A. 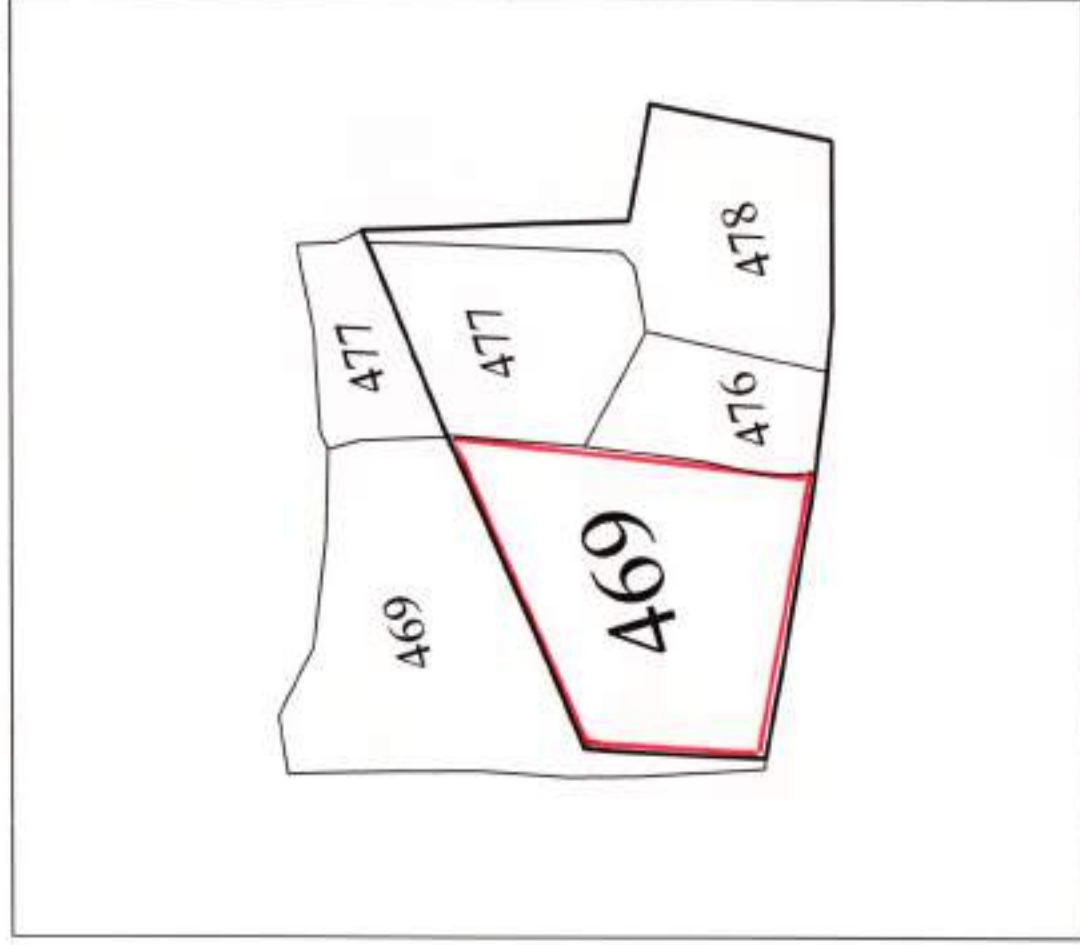

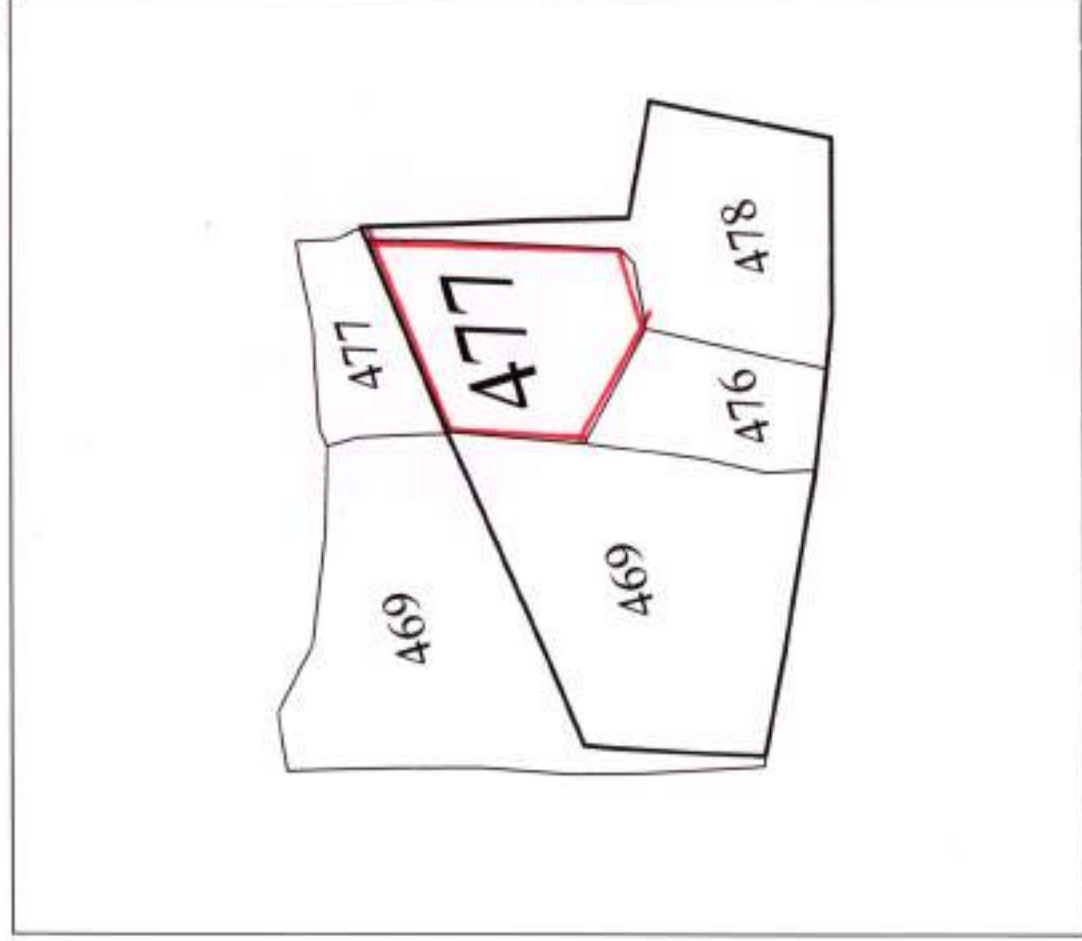
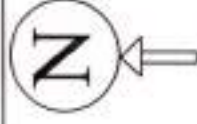
