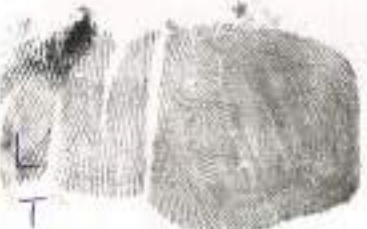

**WHEREAS:-**

1. 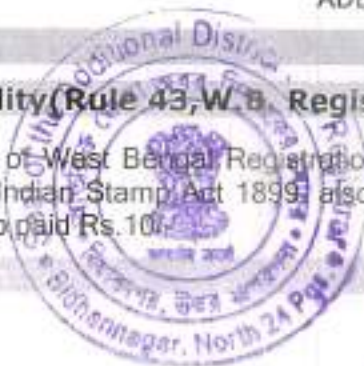
