Terms & Conditions

1 Scope of Work

Construction of foundation-PCC, Footing, tie beam etc. upto plinth & Ground + 5 storey Residential building including RCC, Reinforcement, parapet, column, slab, beam casting, brick work, Plaster, elevation treatment, stair, stair roof, lift m/c room etc. as per drawings, specifications and direction of Architect / Engineer-in-charge.

Supply of Materials

a) Reinforcement steel & cement, door frame, Sand,

Stonechips, Bricks/ACC Blocks.

b) Steel & Cement shall be suppliede free of cost at site including unloading charges. 3% maximum wastage will be allowed for steel & cement.

- 12 Retention Money
- 2.5 % of the bill value will be deducted from every running and final bill and kept as security deposit. The same will be released at the expiry of defect liability period of 6 months after the completion of work.
- 13 Defect Liability Period
- a) Defect liability period will be **180 days** after satisfactory completion of the work.
- b) The agency shall be responsible for mending good any defect found within 180 days from the completion of the work at his own cost.
- 14 Progress of Work
- : Time is the essence of contract. Proportionate work is to be done in proportionate time. Progress must be ensured as per approved time schedule for completion the job.
- 15 Undisciplined/Unsuitable Workers
- Discipline is to be maintained at site. Any worker found undisciplined or considered unsuitable for any reason what-so-ever shall have to be replaced within 24 hours. In this regard decision of Project Manager of **JNPPL** will be final.

16 Labour Laws & labour Act Insurance Policy

The labour forces being directly engaged by the contractor, the question of ensuring welfare facilities to the labourers shall entirely be the responsibility of the contractor. Govt. rules regarding employment, salaries, fringe benefits etc. for the labourers to be followed by the contractor as per norms & laws of the Govt. Xerox copy of labour license is to be submitted at site office. The contractor shall make insurance policy for labourers as per Govt. rules & one photo copy of the same is to be submitted at site office. The contractor shall also indemnify the company in respect of any claim or proceedings and also in respect of any awards of compensation or damages arising there-of. The Employer shall be entitled to deduct the amount of any damage compensations, cost awards, charges or expenses arising or accrue from or in respect of any such claim or damages from any or all such due or to become due to the contractor with out prejudice to Employer's other rights in respect there of.

17 Design Mix

: A design mix of M25 to be prepared from Jadavpur University by the contractor. Cost of preparing such design mix shall be borne by the employer. Same design mix will be used for the execution of the work.

18 Testing of Concrete Cubes :

The agency shall organize making, curing and testing of concrete cubes in time at site. Testing cost to be borne by the Employer

19 Site Development

Desired site development for movement of vehicles etc. is already made.

20 Drawings

Working drawings will be issued to the contractor from site office. Indent for any specific drawing is to be made at least 15 days in advance.

21 Mode of Measurement

Unless other wise stated all the measurements will be carried out as per relevant IS codes - Payment is to be made on actual built-up floor area basis.

22 Access & Co-operation

The employer or his representative shall have a free access at any point of time to the working site. The contractor must arrange every facility and free access to employer or his representatives, architects, consultants to inspect the quality of workmanship, materials etc. The contractor will be required to co-operate with other contractors engaged by the employer and give him proper access and facility to carry out his job.

23 House Keeping

The contractor must maintain the site clean as per direction and to the requirement/desired by the employer.

24 Penalty/Liquidated Damages

Incase of failure on the part of contractor

a) To execute proportionate work in proportionate time.

- b) Non completion of work in specified time The employer may recover 1 % of the contract value after 15 days of delay, & 2.5% of the contract value after 30 days or above of delay.
- c) Employer shall have right to terminate the contract if the delay is beyond 60 days
- : Incase of early completion on the part of contractor
- a) Early completion of work before specified time The employer shall pay 2.5% of the contract value if the work will be completed before 30 days of the specified time, & 5% if the work will be completed before 60 days of the specified time
- The Contractor shall observe all safety measures under local & national law. Any consequences arising out of contractor's failure to adhere to above will be borne by the contractor & the employer will have every right to stop work on account of contractor's non-compliance with safety norms.
- : The Contractor has inspected the site, location & is well aware of the rules and regulation for doing this job and will not plea any ignorance later on.
- Payable area shall be calculated on the basis of the actual area of construction from outer wall to outer wall / column including all balcony / projection / elevation which shall be measured based on drawings without any deduction towards voids in lift, staircase, ducts and ramp area except Ducts bigger then 5 sq.mts are to considered while calculating Floor area. Stair roof and lift machine rooms shall be measured and paid extra at same square feet rate. The quoted rate is an average rate applicable for all floors including stilt floor.
- Contractor quoted price as per annexure B shall be inclusive of supply of Shuttering materials of good quality. It also includes the cost of plant & machinery, labor, nails, shuttering Oil, binding wire expense and supervision charges to complete the work limited to the building area only including PCC, RCC, brickwork, internal and external plaster, reinforcement, shuttering.
