









I desire that the Estate left by me should be divided in the following manner:

i) Rs. 15,000/- Rupees in cash after taxes only also in Gold & my daughter Smt. Sunita Basu apportionable.

The balance of my Estate left excluding Banker's and Lawyer's fee & property at 24 Fleche Point, Calcutta-71, after distribution of Rs. 150,000/- as stated above and also after paying off liability for Income Tax, Death Tax, Estate

Duty, etc. shall be distributed equally amongst my three daughter-in-law viz. Smt. Jyoti Devi Pasari, w/o Sri Pankaj Pasari, Smt. Sudha Devi Pasari, w/o Sri Dimal Kumar Pasari and Smt. Anupama Devi Pasari, w/o Sri Lalit Kumar Pasari.

2) House property at 14 Shakespeare Sarani, Calcutta - 700071 and Jewellery both Diamond ornaments and Gold ornaments shall rest with Mrs. Noolchand Pankaj H.U.P.

This is further to state that Executor shall be at liberty to pay the aforesaid sum of Rs. 150,000/- to Smti Lalita Devi Ghoshal and estimated sum of my three daughter-in-laws as mentioned above even before paying the liability for taxes and Estate Duty. But in that case if the amount paid payable towards taxes and Estate Duty shall exceed the residue of the Estate left, the same shall be borne by my three daughter-in-laws proportionately. However, the liability will be restricted to the amount received by them out of my Estate.

This is the WILL and TESTAMENT made by me, I. Shanti Devi Pasari, wife of Sri Woolchand Pasari at present residing at 4A, Rainey Park, Calcutta 700 019 and by occupation a Hindu Housewife do hereby declare as under :

- PUSHP GOURI PASARI
20 JUNE 1988

 - 1) I have not made any WILL earlier so far as I remember but however I revoke all WILL and TESTAMENT disposition if any therein before made by me and declare this to be my last WILL and TESTAMENT.
 - 2) I appoint my eldest son Sri RATANLAL PASARI as the Executor of this WILL.
 - 3) I desire that the Estate left by me should be distributed in the following manner : -
 - a) Rs. 1,50,000/- (Rupees one lakh fifty thousand) only shall be paid to my daughter Smt. Lalita Devi Jhunjhunwala.
 - b) The balance of my Estate left excluding Jewelleries and Gold Plate and House property at 14 Theatre Road, Calcutta-71 after distribution of Rs. 1,50,000/- as stated above and also after paying all liabilities for Income Tax, wealth tax, Estate Duty, etc. shall be distributed equally amongst my three daughter-in-law viz., Smt. Indu Devi Pasari, W/o Sri Bipinlal Pasari, Smt. Sushila Devi Pasari, W/o Sri Binod Kumar Pasari and Smt. Anupama Devi Pasari, W/o Sri Lalit Kumar Pasari.
 - c) House property at 14 Shakespeare Sarani, Calcutta-700071 and Jewellery both diamond ornaments and Gold ornaments shall vest with M/s Moolchand Ratnali HUF.

This is further to state that Executor shall be at liberty to pay the aforesaid sum of Rs.1,50,000/- to smt. Lalita Devi Jhunjhunwala and estimated sum of my three daughter-in-laws as mentioned above even before paying the liabilities for taxes and Estate Duty but in that case if the amount found payable towards taxes and Estate Duty shall exceed the residual of the Estate left, the same shall be borne by my three daughter-in-laws proportionately. However, the liability will be restricted to the amount received by them out of my Estate.
