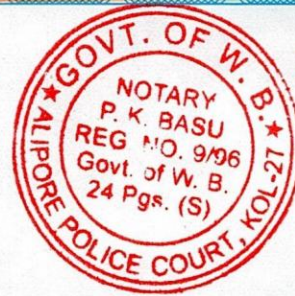

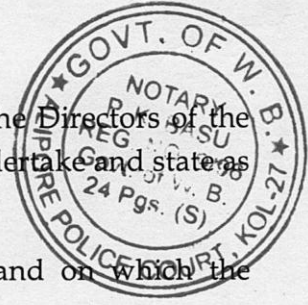

I, **UMESH KYAL**, son of Late Govind Ram Kyal, being one of the Directors of the promoter of the proposed project do hereby solemnly declare, undertake and state as under:



(1) That Iswar Gopaleswar Mahadeb has a legal title to the land on which the development of the proposed project is to be carried out.

AND

a legally valid authentication of title of such land along with authenticated copies of the agreement between such Owner and Promoter for development of the real estate project is enclosed herewith.

(2) That the said land is free from all encumbrances.

(3) That the time period within which the project shall be completed by Promoter is 31/03/20 with a grace period of 6 months.

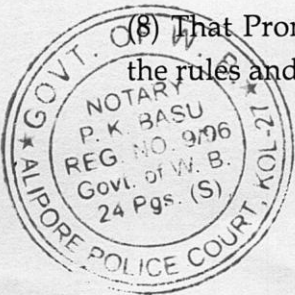

(6) That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdraw is in promotion to the percentage of completion of the Project that Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular Project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

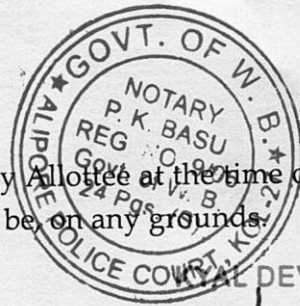
(7) That Promoter shall take all the pending approvals on time, from the competent authorities.

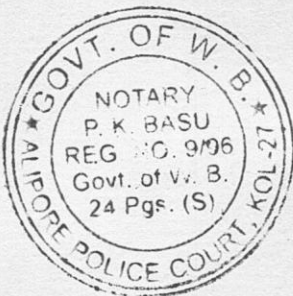
